

Hoop of Life Brings Hope

Hoop of Life Brings Hope: The Ministry of National Security has embarked on a number of strategies, within the context of the Making Life Important (MLI) Programme, which is intended to target persons in "at-risk" communities thereby improving these citizens' quality of life. The Hoop of Life Initiative, a sports-based strategy, is one such viable social intervention.

The Hoop of Life Community Basketball League is designed to provide an avenue for individual and team display of sporting talent and expertise, commitment to healthy sporting rivalry and the development of community peace, cohesion and prosperity. It is a community-centred approach to crime prevention and the improvement of community life. During this initial season, some 60 communities took part with players benefiting from free uniforms provided by the Government as well as travel and insurance benefits.



New Police Stations and Upgrade of Prison Services

In order to improve enforcement facilities, construction has begun on eight new multimillion dollar police stations throughout the nation. These police stations which are located in La Brea, Oropouche, Arima, Maloney, Piarco, Cumuto, Brasso and Moruga will provide a suitable, comfortable environment for law enforcement

officers in their efforts at crime reduction and prevention. The Prison Services are benefiting from an upgrade to the Emergency Response Unit at Golden Grove and commencement of the Remand Prison Extension.

- Emerged victorious in the historic billion dollar OPV arbitration in London. British Aerospace Engineering Systems (BAE) paid \$1.4 billion dollars to the Government.
- The scandalous GTL transaction entered into under the former administration spawned billion dollar arbitrations in New York. This project cost Petrotrin \$2.7 billion dollars and the failed plant must now be sold as scrap metal. The International Court of Arbitration ruled that WGTL had breached its obligations under the guarantee contribution agreement and ordered the transfer of over nine million common shares to Petrotrin. GTL was also ordered to pay full legal costs.
- The Urban Development Company of Trinidad and Tobago ("UDeCOTT") has sued Hyatt hotel for the return of Owner's Remittances in excess of \$150 million dollars.
- Successfully defended a claim of over \$1.2 billion dollars against the State arising out of a gas supply agreement. The matter was settled with the State acquiring a lucrative 50 acre parcel of land on the Point Lisas Industrial Estate and a small payment.
- Took unprecedented action by suing a number of former board directors and officials for a wide range of breaches and violations.
- Managed over TT\$1 billion in legal claims which the Government faced upon assuming office as a result of the exorbitant cost overruns and mismanagement of several mega projects by the former administration.

- The contract price for the construction of the Scarborough General Hospital was \$140 million dollars. In the end, the cost was almost \$500 million dollars. Several complex construction disputes have arisen, which are at various levels in the Court system.
- There has been no legal challenge to the validity
 of the State of Emergency (SOE) because the AG
 provided proper legal advice to guide the PM and
 Cabinet. None of the persons who were detained by
 the police during the SOE have been successful in
 any claims for monetary compensation against the
 State.
- We have maintained a high rating in the area of International Law and Human Rights. Trinidad and Tobago completed its first ever Universal Periodic Review before the United Nations Human Rights Council. In March 2012, Trinidad and Tobago's National Report was officially adopted by the Human Rights Council.
- A Civil Child Abduction Authority has for the first time been established pursuant to the Hague Convention.
 To date Trinidad and Tobago has partnered with 48 countries in the world to protect the rights of children.
- After 18 years in the wilderness, new Commissioners of Affidavits (COAs) and Justices of the Peace have been finally appointed for the island of Tobago. The last COA for Tobago was appointed in 1995.
- Over 100 new marriage officers have been appointed throughout Trinidad and Tobago. They were chosen from all faiths and different parts of the country with an eye for diversity and equality.

Celebrating Our Achievements in Justice

Improving Efficiency and Effectiveness of the Judicial System

- Sites for the construction of new courts were identified at Trincity, Sangre Grande, Penal/Siparia and Carlsen Field.
- Plans commenced for construction of a state-of-the-art Forensics facility.
- Implementation of a pilot Drug Court in San Fernando, moving nonviolent drug crimes out of the overcrowded court system to one with court-supervised rehabilitation.
- Sourcing of a computerised Case Management System to facilitate case preparation and building for the Office of the Director of Public Prosecutions.
- Improvements to legislation through:
 - Administration of Justice (Electronic Monitoring)
 Act, 2012
 - Administration of Justice (Deoxyribonucleic Acid)
 Act, 2012
 - Amendments to the Legal Aid and Advice (Amendment) Act, 2012
 - Joint Select Committee reported on Policy to inform Public Procurement Legislation
 - Report on the National Consultation on Rent was finalised after public consultations. A policy will be developed to guide the formulation of legislation for the protection of landlords and tenants
 - Development of a draft policy and legislation and new prison rules
 - Revised Draft National Consumer Policy
 - Green Paper on Internal Self-Government for Tobago was prepared by the Law Reform Commission in consultation with key stakeholders
 - Draft paper "Transformation of Consumer Protection in Trinidad and Tobago"
 - A review of the Draft Mentoring Policy undertaken through public consultations;
 - A review of the National Youth Mentorship Policy by Cabinet;
 - Joint Select Committee to review a Legislative Proposal on the Prevention of Corruption Act Chap. 11:11 is pending
 - Development of Comprehensive Disaster Management (CDM) Legislation
 - Approval of Offender Management Policy

- Launch of Prison Radio Programme, Rise Maximum Radio, with respect to offender rehabilitation operating alongside academic training for inmates, anger management training and other skill development and social intervention strategies.
- Legislation is being developed towards the establishment of a parole system.
- Code for prosecutors has been developed by the Office of the Director of Public Prosecution in collaboration with the UK.



Celebrating Our Achievements in Legal Affairs

National Consultations on Constitutional Reform

Unlike past efforts at constitutional reform, views are being obtained from as wide a cross-section of the public as possible. A series of 17 public meetings has been mounted across Trinidad and Tobago.

When these public meetings are over, several sessions are to be held with special-interest groups such as civil society/NGOs, business, youth, the Judiciary, the Law Association and the disabled community.



Removal of VAT on 3,000 Grocery Items

In conjunction with the Ministry of Trade, Industry and Investment, the Legal Affairs Ministry, through its Consumer Affairs Division, oversaw the removal of VAT on over 3,000 grocery items. The Consumer Affairs Division of the Ministry of Legal Affairs continues to monitor prices to ensure adherence to the new pricing regime.

World Intellectual Property Day

The Intellectual Property Office mounted an exhibition at their offices in commemoration of World Intellectual Property Day. The exhibition covered all aspects of intellectual property as overseen by the IPO.

WIPO Regional Ministerial-Level Meeting on Intellectual Property

Organised by the World Intellectual Property Organization (WIPO) in co-operation with the Intellectual Property Office, Ministry of Legal Affairs, this meeting was held on November 27 and 28, 2012. The Director General of WIPO presented on the relation of intellectual property to sports, agriculture, creative industries and other areas of interest.

Delivery of Land Titles in Tobago

In just under two years, the Ministry of Legal Affairs has managed to resolve the decades-long problem of Land Titles in Tobago. The long-held Tobago tradition of handing down real estate property to family by word-of-mouth had resulted in many, if not most, landowners in Tobago not having actual Deeds of Title to their properties. While successive administrations were aware of the massive problem, none made any real headway in solving the problem until this administration when new and improved systems and infrastructure in the Registrar's Department made possible the delivery of land titles in far less time than ever before.

World Consumer Rights Day

Through its Consumer Affairs Division, World Consumer Rights Day was commemorated on March 15, 2013. The CAD ran daily tips for consumers in the newspapers and mounted a consumer outreach exercise at City Gate on the day itself.

Launch of Go GREEN Campaign

The Go Green Campaign was launched on Earth Day, Monday April 22nd, 2013. The Go GREEN Programme is an initiative to reduce the environmental impact of the Ministry's activities while building a better future for country and the world. The first phase of the initiative is a plastic, paper, ink and toner cartridge recycling programme. Ministry staff will be educated on ways to recycle both at work and at home, while the public will also be encouraged to participate and learn.



Agriculture & Food Security



The People's Partnership Government recognises that food security is fundamental to people-centred development. This overarching goal for our agricultural sector is set against a global backdrop of food price volatility and declining production levels due to climate change.

New Land Leases

- To increase security of land tenancy, 562 new land leases were extended to farmers to provide opportunities for land ownership, thereby creating access to greater financing possibilities, improving their socio-economic status and raising the profile of the profession
- 2,000 former Caroni workers received leases to lands to which they were entitled and also provided with the necessary infrastructure such as roads, drainage and irrigation ponds for continued agricultural activity.

Improving Access Roads

- Significant efforts were made towards providing an
 efficient access road network to allow food producers to
 get into their fields and to transport their produce out of
 the fields with less effort, lower costs and more quickly
 so that they can offer cheaper prices to consumers,
 increase production and increase their income.
- In fiscal 2012, 40 km of agricultural access roads were rehabilitated successfully (19 roads) and 107 km of access roads (35 roads) were maintained.
- 23.4 km (11 roads) of new agriculture access road networks were constructed in Esmeralda, Exchange No 1, Waterloo, Warren and Caroni.



Push for Locally Produced Foods

- "Put T&T on Your Table" initiative resulted in nine flagship outlets adopting locally grown sweet potatoes into their meal options (sweet potato fries).
- The School Feeding Programme, which serves 150,000 meals daily, used more local content in their meals.
- To encourage citizens to grow their own food, four training programmes were conducted on home gardening and 12 home gardening videos produced and uploaded onto "YouTube".

Commercial Farms

 Three commercial farms commenced in various commodity groups: The Edinburgh Farms, Two Brothers Corporation and Technology Farms commenced on-farm production of rice, citrus and root crops. The Evergreen Ranch is completing land preparation for cattle farming.

Agriculture and Food Security



YAPA

- The Youth Apprenticeship Programme in Agriculture (YAPA), which targets persons aged 18 to 25, saw 615 trainees graduating from Phase 1 and 57 trainees moving into Phase 2 training in agricultural careers.
- YAPA targeted nine areas: Curepe, Wallerfield, Point Fortin, Penal, Chase Village, Princes Town, Sangre Grande, Ecclesville and Tobago.

Celebrating Our Achievements in Housing, Land and Marine Affairs

- In fiscal 2012, 1,037 grants were distributed totalling over \$15m.
- Draw of 500 lots of land under the Land for the Landless Residential Lots Programme.
- Commenced preparation of eight plans and 19 sites, which will yield over 2,000 regularised lots and open spaces for community use and over 1,000 new residential lots for the Land for the Landless programme.
- Additional provisions will be made for persons earning under \$3,000 monthly to purchase starter homes, comprising a lot of land, a foundation and sanitary infrastructure.
- Persons earning less than \$8,000 a month will be able to buy their first home with zero down payment at a 2% interest rate for homes up to \$450,000.
- The Neighbourhood Upgrading Programme provides subsidies to assist with construction costs; financial assistance was granted to 1,241 persons for home repairs and 735 Home Improvement Subsidies were disbursed.
- Site profiling of all squatter settlements were conducted with 331 mapped by the Land Settlement Agency (LSA) in 2012 and 31,836 residential structures mapped using GPS.

- From May 2012-April 2013, 420 certificates of comfort were issued to squatters.
- LSA aggressively patrolled over 200 sites to prevent further squatting; over 300 patrols were conducted.
- A review of the State Lands Act No. 32 of 1918 was conducted and recommendations for its amendment were developed and the introduction of containment provisions in the State Lands (Regularisation of Tenure) Act No. 25 of 1908 was completed.
- 2,500 persons were employed to undertake maintenance, landscaping and environmental clean-up works on Housing Development Corporation compounds and buildings at Beetham, Laventille, Morvant, Maloney and San Fernando in 2012.
- Design and implementation works commenced on the Land Information System database.
- Approval of Office Outfitting Policy aimed at addressing working conditions of public sector employees.
- Primary Schools' Essay Writing Competition targeted Standard 3 students with 34 schools participating.







Celebrating Our Achievements in Healthcare

San Fernando Teaching Hospital

On December 28, 2012, the Honourable Prime Minister Kamla Persad-Bissessar, SC, formally opened the San Fernando Teaching Hospital on Chancery Lane. The country's second teaching hospital, this modern facility is equipped with state-of-the-art equipment. The hospital will provide beds for 216 inpatients as well as parking for 400 vehicles. A variety of services will be offered at the new hospital, including radiology services, urology testing, paediatric and gynaecological care.



Strengthening Policies, Systems and Legislation

- New legislation and policies were developed or completed: Draft Mental Health Bill, Workplace Mental Health Policy, National Cancer Policy, Health Services Accreditation Bill, Draft Optometry Policy, Adverse Events Policy, Amendments to the Regional Health Authority (RHA) Act, 2012, The Policy Framework for the National Health Insurance System, Infection Prevention and Control Polices and Guidelines Manual, adoption of the World Health Organisation's Safe Surgical Checklist, Obstetric and Midwifery Standard Operating Protocol and Health Information System Strategic Plan.
- Hosted Health Seminar on the Future of Herbal Medicine in Trinidad and Tobago in October 2012.



Construction of New Hospitals

- Couva Children's Hospital User Briefs and Request For Proposal were approved with construction commencing in 2013.
- Arima Hospital User Brief was completed and project was tendered.
- Point Fortin Hospital User Brief and Feasibility Study were completed and submitted to Ministry of Finance to inform negotiations for Government to Government concessional loan financing.
- Sangre Grande Hospital Preliminary User Brief was completed and is being developed further.
- Construction of the new Insect Vector Control Division head office and warehouse in Cunupia in 2012.

HPV Vaccination Launched

Some 20,000 girls between the ages of 11 and 12 were targeted to receive vaccinations in the first phase of its voluntary HPV (Human Papilloma Virus) vaccination programme.

In Trinidad and Tobago, the cervical cancer rate is two times higher than worldwide.

New Patient Services and Equipment

- Opened Oncology Department at San Fernando General Hospital.
- Launched first Specialized Multidisciplinary Cardiac Clinic in Pregnancy at the Mt. Hope Maternity Hospital.
- Cell Saver equipment was installed and commissioned at various RHAs.
- Dental equipment and accessories were ordered for various health centres.
- Health care facilities were outfitted with 21
 electrocardiogram (ECG) machines, six cardiac monitoring
 systems, an argon laser machine, seven portable X-ray
 machines, three ultrasound machines and urology
 equipment.

Other Major Achievements

- The final report of the Chronic Non-Communicable
 Diseases (CNCD) Risk Factor (STEPS) Survey was released
 in December 2012, which will shape the Ministry's initiatives
 as it seeks to promote wellness initiatives.
- Fight the Fat T&T Wellness Revolution, was implemented in order to increase the level of physical activity in the national population and to empower citizens to achieve a healthy weight.

Improving Human Resources

- Approval for 135 new foreign nurses and doctors to address existing vacancies within the public health sector.
- The Aides to Nursing Programme was implemented, which will provide support services to the Registered Nurses and Enrolled Nursing Assistants.
- Government scholarships were awarded in specialised areas such as Master of Medicine in Radiation Oncology; a Clinical Fellowship programme and a fellowship in Neonatology at the Centre for Newborn Care.
- Officers were also trained in Cardiac Catheterization Lab activities, Echo Sonography, Bio-Risk Management and Infectious Substance Shipping.







Two persons with end-stage renal disease benefited from the donation of two kidneys, which were successfully transplanted on December 11-12, 2012 at the Eric Williams Medical Sciences Complex.

HIV/AIDS Agency Launched

- The HIV/AIDS Agency was launched to monitor, co-ordinate and evaluate initiatives in the fight against HIV/AIDS nationwide. A National Strategic Plan 2013-2018 directs the expanded national HIV response, focusing on a future without new HIV infections in an environment which promotes respect, education, prevention, care and support for all.
- The agency provides leadership in building and deepening multi-sectoral partnership (public, private, non-governmental) to achieve national commitment and support and ownership of the response of HIV and AIDS; it also co-ordinates and supports activities towards the reduction of the population's susceptibility to HIV and AIDS.
- The agency also establishes national goals and targets for the priority strategic areas and will define a National HIV Policy.



Economic Growth, Job Creation, Competitiveness and Innovation



Our nation has been blessed with bountiful resources. After fifty years as an independent nation, we have continued to optimise the opportunities that spring from the bedrock of our economy, our oil and natural gas.

While we strengthen our advances in this area, our Government recognises that we must also harness the energy of our most precious resource – our people.

We have engineered a parallel strategy of social and economic transformation, steeped in the development of our human resource and strategies that foster investment, entrepreneurship, job creation, innovation and diversification. Our agenda for economic transformation entails a policy shift towards the nurturing of a knowledge-based, technology-driven, innovative and globally connected economy. This is rooted in the enhancement of the skills base of our workforce, the expansion of our exports and growth in our productivity.

On our path to move the economy to a higher growth plane, innovation is the key to the door of success.

It underpins the creation of new and sustainable high value-added industries. It also drives the expansion and development of cultural industries, the performing and visual arts, literary and fashion industries, architectural design and the software industries.

Our Government will also capitalise on the rising global interest in green products and technology through the development of alternative energy sources. We recognise that our nation can transition to a low-carbon society while also increasing our competitiveness in the changing global energy industry by promoting solar and wind energy industries. Inherent in this strategy is our commitment to balancing the protection and conservation of our natural resources with social and economic transformation to ensure environmental security for future generations.

Together we will nurture a society that is firmly built on the foundation of ingenuity, creativity and adaptability as we work towards maintaining a resilient, competitive and sustainable economy.

Celebrating Our Achievements in Finance and the Economy

- Focused in the short term on growth stimulation to bolster economic activity following a period of negative or negligible growth in 2009-2011, resulting in growth of just over 1% in 2012.
- Improved performance in the non-energy sector with growth reflected in the services sector, mainly finance, insurance and real estate services, electricity, water and personal services with a moderate gain in food, beverages and tobacco and a relatively robust increase in wood and other related products.
- The economic and financial buffers of the country remain strong and resilient as the current account surplus increased, foreign exchange reserves remain healthy and the Heritage and Stabilization Fund continues to grow, ending 2012 at US\$4.7bn.
- Unemployment remains reasonably controlled at just over 5% with a marginal increase in the labour force.

- The year on year growth in private sector credit at the end of October 2012 was good, measuring 7.1%.
- At the end of 2012, both Standard and Poor's and Moody's reaffirmed the country's international credit ratings.
- While seeking to establish an enabling environment to support growth, competitiveness and innovation, \$7.5bn or 4.5% of GDP has been committed to the Public Sector Investment Programme.
- The thrust continues towards establishing Public Private Partnerships aimed at redefining the way in which public services are delivered and managed and key stakeholders such as the Chambers of Commerce have been engaged.







Economic Growth, Job Creation, Competitiveness and Innovation



Celebrating Our Achievements in Foreign Affairs

- A Memorandum of Understanding (MOU) was signed with Canada for public sector modernisation as well as a Framework Arrangement for co-operation in the health sector and a MOU for the sharing of correctional information and expertise with regard to prisons.
- Agreed that Canada would co-host a CARICOM Public-Private Partnerships Seminar and business-tobusiness meetings in Trinidad and Tobago later this year.
- An Air Services Agreement has been signed with India for the provision of air services; a Technical Co-operation Agreement was also entered into for co-operation and information exchange.
- A framework Agreement was completed with Grenada for co-operation in energy sector development.
- The High Commission in South Africa has reduced the waiting time for South Africans wishing to secure a visa for our country from 10 working days to 2.
- Acceded to the Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on their Destruction.
- Ratified the Second Revision of the African,
 Caribbean, Pacific (ACP) –European Community (EC)
 Partnership Agreement.

- Ratified the amendments to the Rome Statute of the International Criminal Court, which expand the war crimes related to other serious violations of laws and customs applicable in international armed conflicts.

New Agreements, Licences and Discoveries

- Signed an agreement with Mitsubishi Gas
 Chemical Company and Mitsubishi International
 Corp for the construction of a US850m
 petrochemical complex.
- Signed an Exploration and Production Licence with State-owned Petrotrin and Trinity Exploration and Production PLC, which 6,390 hectares in an oil-prone block in the Gulf of Paria.
- Signed two Exploration and Production Licences with Petrotrin for the TNA (Trinmar) and North Marine Blocks.
- BP Trinidad & Tobago (bpTT) announced its discovery of an estimated one trillion cubic feet (tcf) of gas offshore Trinidad, doubling the estimated gas in place of the Savonette gas field, to two tcf.
- Four blocks were awarded for the Deep Water Bid Round, which has the potential to generate some half a billion US dollars in investment in the first phase, to see the drilling of at least six deep water exploration wells and the acquisition of over 5,330 square kilometres of seismic data.



Diesel and Premium Gasoline Subsidies

- With the clampdown on the illegal export of diesel, the volume of diesel for which subsidy was claimed by the wholesale marketing companies decreased by 14% in 2012 or TT\$101 million.
- With the establishment of the Subsidy Verification
 Unit, the monitoring of purchases of diesel fuel
 by 35 marine and 53 fishing vessels resulted in a
 reduction by 13.6 million litres from March 2012
 to November 2012 compared with the same
 period in 2011 with a reduction in subsidy of
 TT\$57.9 million.
- Effective October 2, 2012, the price of premium gasoline 95 RON was increased from TT\$4.00 per litre to TT\$5.75 per litre for an estimated annual savings in subsidy of TT\$167.6 million.

Moving on Illegal Quarrying

In 2012 the Minerals Division increased its monitoring activities of the 43 licensed quarries operating in Trinidad, and moved aggressively to enforce the Minerals Act and Regulations. The Division conducted investigations into 16 illegal quarrying complaints, as well as complaints against licensed operators. There are currently over 31 persons before the courts on charges related to illegal quarrying.



LNG Activity in 2012

- The Atlantic LNG facility performed quite well in 2012 as compared to 2011 in spite of the higher downtime experienced in 2012. As of November 2012, the average Natural Gas processed by all LNG trains was 2,309,772 MMbtu per calendar day.
- TTLNG entered into a new marketing arrangement for some of its Train 4 LNG cargoes. In August 2012, one cargo was sold at an FOB (Free on Board) price that was 4.5 times higher (US\$24.5 m) than under the previous marketing arrangement.



Strides in Renewable Energy and Energy Efficiency

- Awarded a contract for the conduct of a Wind Resource Assessment Programme (WRAP) on the east coast of Trinidad and Tobago to inform the siting of large wind turbines, which will contribute renewable energy from wind power to the national electricity grid.
- Installed solar photovoltaic lighting externally at nine community centres.
- Launched the National Energy Communication
 Campaign, which revolved around an interactive
 website, www.myenergytt.com, providing
 comprehensive information about the energy sector.
 This campaign won the Gold and Silver awards for
 Best Interactive Website and Overall Campaign
 respectively at the Caribbean Advertising Federation
 awards.
- Approval has been granted to install solar
 photovoltaic lighting and solar-powered distilled
 water stills in 25 schools across the country.
 Coupled with this initiative is a wide-scale training
 of 100 schoolteachers to deliver specific lessons on
 renewable energy and energy efficiency.



- Outfitted three buildings with solar and wind power, the University of Trinidad and Tobago's O'Meara campus, the Mt. Hope T&TEC building and the Islamic Home for Children, which are connected to the national electricity grid.
- Acquired a hybrid vehicle for its fleet, which runs on both gasoline and power generated by the vehicle's motion and stored in special battery compartments.
 The Ministry is developing incentives that will make energy-hybrid and energy efficient vehicles more affordable.

Over the past year, the Ministry of Local Government has made significant progress in achieving its goals for better quality services, better communities and stronger councils.



Regional Corporations

For the first time in the history of local government, Corporations were able to receive draw downs of allocations from the Ministry of Finance within the first month of the Budget being passed in September 2012. It is also the first time that all budgetary allocations have

been spent within the first nine months of the fiscal year. This is an improvement on past performance where much of the funds released in the second quarter would remain unspent by the end of the fiscal year.



The focus of this initiative involves restructuring public service organisations from a pyramid to a diamond-shaped structure. These frameworks provide information on the selection process and help to ensure transparency of the process.

- By the end of 2012, the Utilities Assistance

 current 10,616 persons, many of whom will now
 receive grants of up to \$200 and \$684 towards

 Bulk power projects near completion such as the Cove-Milford Bay cable section of the Tobago network and the acquisition of 42,000m of overhead line hoses, 22,400 insulators, 20,000 long-stalk pins and 36,000 polymeric insulators.
- TTPOST endured we are the first Caribbean country to introduce our own postal code and S42 addressing standard, the adoption of an international best practice that has only been implemented in some 29 countries globally.





Celebrating Our Achievements in Environment and Water Resources

- Northern Range Watershed Protection Research Project (Forest Protection), which was undertaken to carry out watershed studies and preparation of management plans and programmes of selected watersheds.
- Major river improvement works at Honda River, Caroni River, Soledad River, Marabella River, Dunder Hill River, Tunapuna River, Blackman Ravine, Tacarigua River, San Juan River and many other nationwide waterways. These projects helped developed economic growth, job creation, competitiveness, diversification & innovation.
- Refurbishment and upgrade of major water treatment plants including Granville Water Works, Biche Water Treatment Plant, Acono Water Treatment Plant, El Socorro Water Works, Valsayn Water Works, Edinburgh 500 Water Works. This increased the plants' reliability and water quality improvement.
- Improvement of Trinidad and Tobago's
 wastewater system improved effluent quality
 activities are identified to take place for private
 wastewater treatment plants in the Maloney, San
 Fernando, Couva and Chaguanas Catchment;
 this included rehabilitation/expansion of
 wastewater treatment plants, integration
 and expansion of the wastewater collection
 system, the construction of lift stations and
 the decommissioning of existing wastewater
 treatment plants.
- WASA staff received specialised training in Wastewater Management Organizational Efficiency.







Celebrating Our Achievements in Labour, Small & Micro Enterprise Development



- The establishment of a register for domestic workers was a priority project to provide vital labour market information of domestic workers as it formulates policy.
- Developing a revised Micro and Small Business Enterprise Policy with consultations ongoing.
- IBIS, the National Integrated Business Incubator System, trained over 100 candidates in 2012.
- FairShare, a programme which gives access to Government contracts up to \$1 million to qualifying MSEs and Co-operatives, allows MSEs to market themselves through an online web portal, www.fairshare.gov.tt.
- CONNEX, an exposition which showcased the Ministry's and its agencies' services was held in July 2012 and centred around the theme, "Meeting Our Labour and Small and Micro Enterprise Demands"; it showcased some 150 co-operatives and businesses from various sectors.
- Celebrated International Year of Co-operatives 2012 with an inter-faith service, a distinguished lecture series themes, "Rebuilding Economies: Strengthening Credit Unions for this responsibility", a primary schools'

- essay-writing competition and the production of 20 cooperative educational radio programmes called "Hand in Hand". A theme song, music video and short film were also developed.
- A Memorandum of Understanding to address AIDS in the workplace was signed with 13 organisations ranging from trade unions to private sector organisations and the informal economy; a training and technical support centre was also established – one of only two such centres in the world
- Successfully completed in excess of 40 wage negotiations within the State sector in last 30 months.
 Most of these were unresolved wage issues that date as far back as 2008. Government has also completed negotiations with several state bodies for periods extending past 2014.
- \$90 million settlement between the Public Transport Service Corporation (PTSC) and the Transport Workers Trade Union.
- Negotiations to increase by 25% in 2013 and 2014 grants for Maternity and NIS benefits.

Poverty Alleviation

- Initiatives have been geared towards reducing the number of persons living below the poverty line by 2% per annum.
- From October 2011 to July 2012, 25,002 persons were already in receipt of a Public Assistance Grant worth over \$273m with 4,830 new persons at a cost of over \$10m; 1,554 of these recipients also received free bus passes.
- 1,850 persons benefited from the General Assistance Grants worth over \$14m, which included housing assistance, household items, medical equipment, domestic help, dietary, clothing, funeral, education, special child, pharmaceutical, house rent and school supplies.
- By July 2012, 23,797 persons were in receipt of the Disability Assistance Grant worth some \$318m with 2,119 new persons benefiting at a cost of \$14m; 1,121 of these recipients also received free bus passes.
- During fiscal 2012, the Direct Effect Initiative was conducted in the following areas: Edinburgh 500,
 Sea Lots (on two occasions), Bagatelle/Diego Martin, Maloney, Beetham Estate, John John, Laventille,
 Carlsen Field, Cashew Gardens, Windsor Park,
 Rivulet Road, Calcutta Settlement, Dow Village,
 Rivulet Road, Indian Trail, Basta Hall Village,
 Beaucarro Village, Uquire Road, Milton Village and
 Mc Bean, Moruga/Tableland.

- In September 2012, the Poverty Reduction through Social Strategies (PRESS ON) Initiative was launched, which involves a collaborative effort among Government ministries and the private sector to improve access to a number of Government services. The People's Issues Resolution Unit collected 121 issues at this event.
- Approximately 100 youth in Cocorite were screened for the Special Youth and No Crime Initiative for admission in sound engineering, radio broadcasting, deejaying and computer literacy courses.
- In an effort to assist street dwellers, 26 public reports were received and investigated; 404 clients were assisted with fulfilling appointments for medical diagnostic screening and assessment; 422 street interviews were conducted by field officers and 39 clients were persuaded to relocate to the Centre for Socially Displaced Persons.
- An Inter-Agency Unit on Street Dwellers was established to oversee the removal, assessment, rehabilitation and reintegration of Street Dwellers.
- Under the Deportee Support Programme, 53 clients were received at Piarco International Airport; 20 clients were referred to Vision on a Mission and 50 clients were successfully reintegrated with their families.
- Under the Elderly Relocation Programme, three clients were relocated to homes for the elderly and there are currently 35 persons housed in elderly care facilities.
- Under Social Work Services and Intervention programmes, 136 clients were referred to the Centre for Socially Displaced Persons; 349 clients received social work services and six clients were referred to social programmes.
- At the New Horizons Centre, a residential life and employment skills development facility for adults, clients benefited from 898 social work intervention exercises; 40 clients were enrolled in vocational training programmes; 48 clients were employed and 16 clients were successfully reintegrated.
- Completed the User Brief for the Centre for Persons with Disabilities to be established at Carlsen Field, including services, and the tendering process has commenced.









Direct Deposit

- The Direct Deposit service was launched whereby cheques are deposited directly to the bank accounts of clients on a phased basis, beginning with the senior citizens' Pension, and ultimately benefiting 65,000 Senior Citizens.
- This initiative will also be extended to facilitate recipients of Disability Grants and Public Assistance Grants for fiscal 2013.

Senior Citizens' Services

- Replacing the Senior Citizens' Grant, the Senior Citizens' Pension was increased to a maximum of \$3,000 monthly.
- The minimum National Insurance Retirement pension was increased to \$3,000 per month and the minimum Public Servants' Pension was increased to \$3,000, so that retired public servants will be receiving a minimum total benefit of \$6,000 per month.
- Reconstruction of La Brea Home for Senior Citizens.
- Launch of Third Regional Intergovernmental Conference on Ageing in Latin America and the Caribbean.

 Launch of the Woodbrook Senior Activities Centre and financial assistance provided by Tobago House of Assembly at two centres in Tobago.

- Built, renovated and upgraded 15 community centres throughout the country with auditoriums, audiovisual rooms, training kitchens, computer rooms, gyms, classrooms and bathrooms accessible for the differently abled at Malabar Phase IV, Sisters' Road, Upper Malabar, Second Caledonia, Duranta Gardens, Roystonia, Tumpuna, Golconda, Talparo, Carapichaima, Quarry Drive, Patna River Estate, Jerningham Junction Caroni and Cumana Toco and a Homework Centre at Mango Rose.
- Construction of community centres in progress in 21 areas: Ortoire, Palo Seco/ Los Charros, St John's Village, Palo Seco Settlement, El Dorado, Samaroo Village, St. Augustine (South), Calvary, North Manzanilla, Carapo, Cocorite, Vessigny, St Helena, Matelot, L'Anse Noir, Chatham, Gasparillo, Santa Cruz, Point Fortin Civic Centre, San Fernando (North) and Harmony Hall.
- More than 16,000 persons were trained in over 60 courses through the Community Education Skills Programme.
- Over 5,000 persons benefited from implementation of 150 projects under the Community Awareness and Sensitization Programme.
- Hosted a series of SHINE: Spotlighting Community concerts to showcase and honour talented groups and individuals.
- Launched the 50th Anniversary Celebrations of the Prime Minister's Best Village Trophy Competition, "Celebrating Achievements – Shaping the Future".

- A total of 60 persons have been trained in Peritoneal Dialysis though the Geriatric Adolescent Partnership Programme (GAPP).
- Launch of the first Biennial Community Development Partnership Forum and Exhibition and Inaugural Community Heroes Award 2013.
- Community Development Fund (CDF) formally handed over 20-seater vehicles to the YMCA and the National Centre for Persons with Disabilities.
- The CDF launched the Community Volunteer Programme and trained 21 volunteers in Poverty Alleviation and Community-based Programmes and Services.
- Export Centres Company Limited distributed starter kits to 35 graduates of its 2012 Craft Training Programmes; over 500 persons graduated from these programmes.

- Nine mediation centres have been established and some 35,000 individuals have received services.

- Introduced the Food Preparation and Home Management Programme for men and boys.

- Hosted the National Youth Volunteerism Launch/ Competition.
- For 50th anniversary celebrations, the Ministry launched the Leaving Our Mark: Vacation Camp Experience programme called "Camp Footprints" and "Camp Vibe", themed "Our Culture, Our Heritage" totalling 52 camps and 2,785 children and youth.
- Hosted the 5th Annual National Youth Awards.
- The Cabinet approved the "National Youth Policy" and implementation has begun.

- Consultative forum for 140 social workers to build a platform for a national integrated social service delivery system.
- Phased implementation commenced on the "National Strategic Plan for Child Development".
- The Children's Act, 2012, introduced a more stringent regime to punish sexual offences against children.

Children's Authority of Trinidad and Tobago

- Completed a GAP analysis of 50 community residences, which will contribute to the development of Standards and Regulations for community residences.
- Developed and currently operationalizing a "Child Protection Registry".
- Established a "Child Protection Library" in collaboration with NALIS.

Celebrating Our Achievements in Education

Integrating Information Communication Technology: The Educational Laptop Initiative

- 17,362 laptops were distributed to Form 1 students in 152 secondary schools for the academic year 2012/2013 with 29 software programmes.
- Distributed 467 laptops to primary school principals.
- Conducted training for 7,734 teachers in a series of ICT courses.
- Collaborated with Microsoft Inc. to host three eCAL ICT in Education Innovative Award competitions.



Improving Infrastructure in Schools

- Works were completed at 350 primary and secondary schools, of which, 77 schools were repaired during the July-August 2012 vacation period.
- Commissioned and opened 13 fully functional, state-of-the-art ECCECs.
- Commenced preparation for the establishment of Public-Private Partnerships in the provision of Early Childhood Care and Education by hosting district consultations to secure stakeholder buy-in.
- Over the past two years, 13 primary schools have been constructed with the construction of 42 replacement primary schools scheduled. Fifteen schools will be constructed in fiscal 2013.
- Over the past two years, four secondary schools have been completed and formally opened, namely: Marabella South, Aranguez North, Couva West Government and Five Rivers Secondary. Construction work is ongoing at eight secondary schools



Improving Students' Overall Academic Performance

- In 2012, 18,542 students in Standard 1 and 19,948 students in Standard 3 wrote the National Test in Mathematics and Language Arts. In Mathematics, there was some 40% improvement in Standards 1 and 3, while literacy levels improved by about 50%.
- The Academic Performance Index (API) indicated that the number of schools under Academic Watch decreased from 120 in 2011, to 28 in 2012.
- There was an increase in the number of schools in the "Excelling" band from 15 in 2011 to 121 in 2012 while no schools fell into the "Academic Emergency" category.

Teacher Development:

- Commenced the conduct of a baseline study of teachers' performance in May 2012, which will inform a model for the professional development of teachers.
- Conducted professional development training for 35 curriculum officers to support teachers in the delivery of the Health and Family Life Education (HFLE) curriculum.
- Improved teacher skills in all eight core subjects by training 160 teachers.
- Held a leadership conference for principals and administrators: "The Leader in Me".
- Commenced the reclassification process for secondary level teachers.
- Conducted workshops on Discipline for Principals of Secondary and Primary Schools.
- Completed review meetings with TTUTA dealing with the review of the Performance Management Appraisal Process Manual with approval obtained.



Continuous Assessment Component

- The Continuous Assessment Component (CAC) of the Secondary Entrance Assessment was introduced and will contribute 20% of the final mark.
- Implemented an intensive training programme to support the implementation of CAC.
- Trained 72 facilitators, 828 Standard Five teachers, 609 Standards Four teachers.
- Developed 11,000 training manuals and 3,000 CDs for distribution as teaching aids.
- Scaled up the resources at 557 primary schools to support the delivery of the expanded curriculum.
- Training for 34 curriculum officers, 41 school supervisors and a group of 121 persons as CAC monitors.

Celebrating Our Achievements in Science and Technology





- The 2012 Awards for Excellence in Science,
 Technology and Innovation recognised 17
 outstanding Trinidad and Tobago scientists for
 their contribution in their respective fields. The
 categories of awards were for engineering,
 medicine, natural science, applied science and
 technology, innovation in arts and culture. Awards
 were also offered for Junior Scientist and Junior
 Engineer.
- Staging of the visiting exhibition, India: A
 Culture of Science. Over 51,000 visitors (60%
 of whom were students representing over 300
 educational institutions) were given a snapshot of
 India's and humanity's progress in science and
 technology, from ancient to modern times and
 an understanding through India's example of the
 central role that science & technology plays in
 driving growth and development and economic
 diversification.
- The Environmental Solutions for Rural
 Communities programme was piloted in Toco,
 Moruga and Barrackpore. Public education
 sessions on water conservation impacted over
 2500 students from 11 schools. The initiative also trained 75 people in these communities to install special rainwater harvesters, which was completed in nine schools.
- The 11th Annual Caribbean Youth Science Forum (CYSF) brought together 200 sixth form science students from Trinidad and Tobago and six countries in the region, with a key aim of inspiring them to pursue STEM careers. They met leading local and international scientists; developed their critical thinking and design skills and saw "science in action" at research labs or applied in the field and industry.

NIHERST

- NIHERST's Science & Technology statistical research supports capacity building in knowledge management for the knowledge-based economy. In 2012, work focused on reporting on or publishing the results of: Survey of Innovation in the Tourism Sector, 2009; Innovation in the Publishing, Printing and Paper Converter Industry, 2010; Survey of Science in Secondary Schools, 2011 and Energy Consumption by Households, 2011. New surveys undertaken were on: Innovation in the ICT sector for 2012; the Public Perception of Science, 2012 and Science and Technology (S&T) Indicators, 2011.
- NIHERST's extensive non-formal education programmes, offered through the NIHERST-NGC National Science Centre (NSC) and the institute's Innovation Unit, focus on science, creativity, innovation and entrepreneurship. The highly interactive and entertaining approach makes learning easier and more enjoyable. In 2012, over 77,100 adults and children took part in initiatives and activities including: Robotics and electronics workshops for teacher and students; Science & Technology Vacation Camps, Innovation Camps, the launch of Sci-Eng Club, Science Whizz competition and the Community-centred Design & Innovation programme.
- A key outreach activity of the NSC is its
 Community Science Week programme that takes science to the people in rural communities.
 Two science weeks were held in Preysal and in Tabaquite, attracting 9,000 students from pre-school to secondary as well as adults.
 The programme featured interactive exhibits, workshops, science shows, lectures/discussions, a career day and telescope viewings.
- The Science Music Video Competition was launched with the aim of encouraging young people between the ages of 14 and 28 to promote scientific knowledge and communicate on issues related to science in development, using a medium that is very popular with them.
 150 persons received training in music video production to help them improve the quality of their entries.
- In terms of educational resources, a DVD on climate change was completed and distributed to schools. It is a unique resource with games, simulations, quizzes and information designed to educate Caribbean students on the causes and impacts of climate on Caribbean SIDS and measures for mitigation and adaptation. An animation video on oil spills was also completed.

Celebrating Our Achievements in Tertiary Education and Skills Training

- Thirty acres of land were dedicated to building the future main campus facility of the College of Science, Technology and the Applied Arts of Trinidad and Tobago (COSTAATT). Construction of the campus began in September 2012.
- Work commenced on the Academy of Nursing and Allied Health in El Dorado.
- Members of the St. Augustine Education City committee have been appointed.
- Sod turned on the site for the Centre for Workforce Research and Development on the St. Augustine campus of The University of the West Indies.
- Hosted a one-day symposium on workforce research and development.
- Launched Jobs and Career Coaches to give counselling and advice on job placement, career enhancement and interviewing techniques.
- Launch of the Trinidad and Tobago Research and Education Network (TTRENT) to allow students and researchers to engage with international and regional e-learning content.

National Energy Skills Centre

- The Vehicle Management Corporation of Trinidad and Tobago (VMCOTT) and the National Energy Skills Centre (NESC) launched a Workforce Assessment Centre and Trade School to provide opportunities for advanced level training to residents of Port of Spain.
- Graduation of the first group of Nigerian trainees from (NESC) in automotive services maintenance, crane operations, shielded metal arc welding and industrial mechanical maintenance.
- The Public Transport Service Corporation (PTSC)/NESC Trade School and Workforce Assessment Centre is formally opened at PTSC headquarters. Sixteen students have been enrolled in its Heavy Equipment Technician Apprenticeship Programme.

- The Metal Industries Company Limited (MIC) unveiled two VRTEX 360Machines, educational training tools that are designed to accelerate welding training through the utilization of virtual reality.
- Participated in the International World Skills
 Competition, hosted by the National Training
 Agency (NTA), which provides hundreds of
 young students and apprentices from around the
 world with the opportunity to compete before
 government officials, the industry, sponsors,
 various training providers and the media in
 some 40 skill areas that are assessed against
 demanding international standards.
- The Masters of Arts in Leadership in Technical and Vocational Education and Training (TVET) and Workforce Development was launched at The UWI, St. Augustine.

- The University of Trinidad and Tobago (UTT) awarded a scholarship to Olympic gold medallist Keshorn Walcott and the first graduate of UTT's Artist Diploma in Music Performance programme, Stephan Hernandez.

Youth Training and Employment Partnership Programme (YTEPP)

- Launched its Public Access Learning
 System (PALS) at its Valencia Training
 and Enterprise Academy and unveiled
 this country's very first free "hole in
 the wall" computer, which is located
 in the wall of the Academy on the
 Valencia Main Road.
- Hosted its Funding and Business
 Ownership Seminar to link trainees
 of its Small Business Management
 programme to experts in the area of
 Micro Entrepreneurship.
- Launched Signature Creations, an income-generating Business Incubator designed to encourage micro entrepreneurship in the cosmetology industry.
