

# ACTON PLAN BRIEF - Desal Shutdown - November 20th to 25th, 2013

### **1.0** Identified Situation

A planned six (6) day shutdown of Desalcott from November 20<sup>th</sup> to 25<sup>th</sup> 2013 to

- i. Facilitate expansion works necessary to increase delivery to 40 mgd by January 2014.
- ii. Carry out routine maintenance works.

This will result in a production daily deficit of approximately **32** mill/gall/day for the period.

## 2.0 Contingency Measures

Contingency measures have been put in place in the following areas.

1	Production Facilities	<ul> <li>✓ All production facilities will be fully operational with a 100% reliability.</li> <li>✓ Caroni WTP will maintain optimum production of 75 mgd of which, South will receive 47 mgd and North 28 mgd.</li> </ul>
3	Redistribution of water Scheduling	<ul> <li>Schedules will be readjusted in Central, South East, South West and North West Trinidad to supplement supplies.</li> </ul>
4	Water Trucking	<ul> <li>WASA and contracted tankers will provide a fleet of 91 trucks to be used as and when needed. In addition North tankers will be redeployed to South with a skeletal fleet left operating in North.</li> <li>Additional filling bays will be set up at Caroni, Carlsen Field, Freeport and Malgretoute.</li> </ul>
5	Storage Capacity	<ul> <li>Critical reservoirs to be filled: California Tank, Naparima Reservoir, Marryat Reservoir, Chacon Reservoir, Siparia #1 Tank, Quarry/Bennette tanks, Center Mountain, Mt. Hope, Picton II. Total Reserve : 24.9 Million Gallons.</li> </ul>
6	Point Lisas Industrial Estate	✓ A 24/7 supplemental supply from Caroni will be made available to the Industrial Estate at a minimal pressure of 21 psi. Supply will be monitored 24/7.
7	Additional Crews	✓ A total of 87 In house and Contracted crews will be available to effect pipeline repairs
9	Internal Water Conservation measures	<ul> <li>There will be a temporary stoppage of Pressure Testing and Flushing of mains to conserve supplies.</li> </ul>
10	Daily Communication with all major stakeholders	$\checkmark$ All major stakeholders will be apprised as necessary.

### 3.0 Critical Customers

A total of 172 schools and 75 public institutions have been identified as critical customers. These include

- ✓ Schools
- ✓ Medical Institutions
- ✓ Fire Services
- ✓ Cities/Borough
- ✓ Key Commercial Districts.



These institutions have been singled out for special focus in terms of truck borne supplies. They will be monitored and reported on twice daily. In addition bottled water is being provided to a total of 22 schools and Health Institutions in critically affected areas where water schedules are stringent. The focus is providing bottled water for drinking purposes while truck borne water can be utilised for flushing of toilets and washing of hands.

## **4.0 Sensitive Areas**

For domestic customers, "Hot spot" areas highlighted in red in Table 2 are expected to face the brunt of the production deficit. These areas will be continuously monitored and reported on by Technical personnel.
