PROPOSALS FOR MEDIA SERVICES—PROFESSIONAL DEVELOPMENT SECONDARY EDUCATION MODERNIZATION PROGRAMME—MINISTRY OF EDUCATION

PROPOSALS are invited from firms for Media Services required for implementation of activities of the Professional Development sub-component of the Secondary Education Modernization Programme (SEMP) for the Ministry of Education (MOE) viz;

Preparation of a set of training materials in five (5) media (print, video web-based, Power Point and overhead transparencies) for use in a range of one-day training sessions on SEMPCU for building sector-wide ownership.

Preparation of a production plan with agreed deadlines between the consultant and the MOE for all draft and final deliverables.

Preparation of a detailed proposal for review and approval of the MOE on the design and indicative content of the following training materials:

- (a) a 24-page information booklet on SEMPCU;
- (b) a 30-minute video script on SEMPCU;
- (c) a web-site on SEMPCU utilizing the booklet and wide material;
- (d) a Power Point presentation; and
- (e) approximately 25 overhead transparencies to assist workshops presenters and invitees.

Undertaking editorial research using print documents, press releases, interviews and other sources to prepare draft manuscripts for the training materials.

Obtaining without additional cost to the contract all photographs agreed for the illustration of the print booklet, web-site and Power Point presentations.

The objective of the SEMPCU is to expand the secondary level of the education system. It is jointly financed by the Government and the Inter-American Development Bank (IDB).

- (b) a training video of 30 minutes in 3 segments; and
- (c) a web page incorporating similar basic material, the nucleus of a SEMPCU website.
