## PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE ASHTANG YOGA ASSOCIATION OF TRINIDAD AND TOBAGO AND FOR MATTERS INCIDENTAL THERETO

NOTICE is hereby given under the provisions of Standing Order 83(3)(b)(i) of the House of Representatives of a Bill entitled "An Act for the incorporation of the Ashtang Yoga Association of Trinidad and Tobago and for matters incidental thereto", which it is proposed to introduce in the House of Representatives. The Bill is published as a Supplement to the *Trinidad and Tobago Gazette* and copies may be purchased from the Sales Section, Government Printery, 2-4, Victoria Avenue, Port-of-Spain.

The object of the Bill, among other things, is to incorporate the Ashtang Yoga Association of Trinidad and Tobago of 19, Bownath Trace, Penal, in order to enable it to hold property and to otherwise carry out its aims and objects.
