GOVERNMENT OF ST. LUCIA—INVITATION TO BID FOR THE NORTHERN WATER SUPPLY IMPROVEMENT PROJECT

THE GOVERNMENT OF ST. LUCIA (GOSL) has secured a loan from Agence Francaise de Developpement (AFD) to construct a new and dedicated water transmission pipeline from Bananes Bay (near Port Castries) to Choc Estate Storage Facility, aimed at improving the water supply to the northern areas of the island.

The Ministry of Planning, Development, Environment and Housing is implementing the project through a Project Management Unit (PMU), which will be responsible for the day-to-day management of the project. Engineering Consultants have been retained by GOSL to prepare designs and contract documentation, and to assist in the tendering exercise and supervision of construction.

1. *Scope of Works:* The works consists of the construction of a 20-inch (500 mm) cast iron pipeline approximately 6600 m long including procurement and laying of pipes, trenching along roads and in the airport area, construction of a reinforced concrete corridor through the seaport area, bridge crossing and road reinforcement.

2. *Type of Tender:* International Competitive Bidding.
