2. The courses are particularly suitable for providing professionals with further specialised studies and are offered in such areas as Economics, Engineering, Mathematics, Regional Planning, Agricultural and Forestry Sciences, Environmental Sciences, Public Health Systems and Education Science.

3. Preference may be given to study in those areas which have been identified as priority in terms of the country's human resource requirements.

*Eligibility Criteria*

4. Applicants must—

- (a) be citizens of the Republic of Trinidad and Tobago;
- (b) possess a Bachelor's or Master's degree from a recognised university relevant to the course of study as specified in the course description;
