No.—100(E)(1)

FUROSEMIDE (LASIX)

In these Rules—

In the third (3rd) line change the word "Fourteen" to "Thirteen".

Rule 100(F)(5) (new)

A horse which has been eligible for the administration of Furosemide may be removed from the Bleeders List, only upon written authorisation of the Official Veterinarian.

Such certification must be applied for and issued before the horse takes entry for a particular race day.

Horses for which applications have been received for removal from the Bleeders List shall be required to participate in an official extended workout to the satisfaction of the Official Veterinarian. After such workout, the Official Veterinarian shall conduct an Endoscopic examination to confirm its removal.

All applications for removal must be accompanied by a fee of one hundred and twenty-five dollars (\$125.00) plus VAT.

Horses which have been removed from the Bleeders List and wish to re-enter that list for the administration of Furosemide, must qualify via the same method as when it was originally placed on List, pursuant to Rules 100(F)(1) and (2), and will be subject to all subsequent Rules regarding horses on the Bleeders List.

Current (5) becomes (6).

The above amendments to the Rules of Racing were approved at a meeting of the Trinidad and Tobago Racing Authority held on Thursday 7th June, 2001.
