THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through the Ministry of Health has initiated a comprehensive Health Sector Reform Programme partly financed by a loan from the Inter-American Development Bank.

2. The Ministry of Health and Regional Health Authorities recognise a need to improve health facilities maintenance programmes. The objectives of this technical assistance is to strengthen maintenance and engineering programmes through the development and implementation of a model maintenance and engineering service in one selected Regional Health Authority that will be "rolled out" to hospitals and primary health care facilities in all the Regional Health Authorities.
