Offsetting of Arrears Owed to Public Sector Employees

Over the last seven (7) years Public Sector Employees have been accessing several mechanisms for the offset of arrears owed to them. Crucial to the offset exercise was the issue of Liability Statements to eligible Public Sector Employees. i.e. persons who were employed in the Public Sector and to whom arrears were due for the following periods :

- (i) 1st February 1987 to 28th February 1992
- (ii) C.O.L.A. for the period 1st March 1992 to 31st December 1994.

The Offsetting exercise is coming to a close with the final mechanism being the Cash Payment of Residual Balances.

If you are an eligible Public Sector Employee and you have not yet benefitted from the offsetting exercise for any of the following reasons you are advised to contact the Ministries/Departments where you were employed during the relevant periods:

- (i) Never received liability statement(s)
- (ii) Unresolved problems with existing liability statement(s)
- (iii) Lost liability statement(s)
- (iv) Never accessed any mechanism

Note: Contact should be made with the relevant Ministries/Departments before 31st December 2001.
