IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Johnson and Johnson Limited, Churchill-Roosevelt Highway, Trincity—Pharmaceutical Articles, Sanitary Napkins, Toothbrushes, J Cloths, Cotton Swabs, Sweeteners, etc., and such other goods as I may subsequently approve.
