## APPOINTMENT OF PRIVATE WAREHOUSES

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Ralph M. Newton, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Capil's & Company Limited, of Lot No. 35B, Tissue Drive, New Trincity Industrial Estate, Trincity—refrigerators, washers, gas ranges, electric ranges, television sets, stereos, videos, spare parts, lawnmowers, air-condition units, furniture, etc., and such other goods as I may subsequently approve.

TECHNICAL PROPOSAL FOR CONSULTANCY SERVICES—SCARBOROUGH HOSPITAL—COMMISSIONING/  
OPERATIONALISATION OF THE NEW HOSPITAL AND DECOMMISSIONING OF THE OLD HEALTH SECTOR  
REFORM PROGRAMME—MINISTRY OF HEALTH, IDB LOAN NO. 937/OC-TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through the Ministry of Health (MOH) has initiated a comprehensive Health Sector Reform Programme (HSRP) aimed at improving the quality of health care by changing organizational structure(s) and behaviour(s). The costs of the HSRP are in part financed by a loan from the Inter-American Development Bank (IDB).

2. Technical assistance is being provided to the MOH in the planning, development and implementation of a number of strategies and systems including organisational; management and funding arrangements, primary health care and clinical information systems. Policy directions emphasize a shift in resources to primary care, a restructuring of secondary care and a resource allocation based on health need. Service devolution to Regional Health Authorities and the upgrading of physical infrastructure in both the primary care and hospital sectors from integral components of the overall reform initiative.

3. The development of a new hospital facility in Tobago is a key input into the reform strategy. A number of studies have clearly identified the need for a new hospital in Tobago despite many recent improvements to the existing facility. The Tobago House of Assembly has also identified the urgent need to replace the current Scarborough Regional Hospital (Fort George site) with a new facility. An architectural firm has been contracted to design and develop a programme to construct a new Scarborough Regional Hospital (Signal Hill site). Construction is expected to begin in late 2002.

4. The objective of this consultancy is to provide expert assistance to the Tobago House of Assembly, Tobago Regional Health Authority, and the existing Scarborough Regional Hospital (Fort George) in the design and implementation of a commissioning/operationalisation plan for the new Scarborough Regional Hospital (Signal Hill) and the decommissioning plan for the Old Hospital.
