APPOINTMENT OF PRIVATE EXCISE WAREHOUSE

(*Excise General Provisions Act, Chap. 78:50*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the General Provisions Act, Chap. 78:50, I, Ralph Newton, Acting Comptroller of Customs and Excise, acting under the provisions of section 3 of the said Act, do hereby appoint the place specified in the Schedule hereunder to be a Private Excise Warehouse for the manufacture and storage of Beer, Malta, Stout and Shandy or other goods as may subsequently be approved.

SCHEDULE

- (1) An enclosed area measuring approximately 30 metres on the northern side, bounded by "Furniture Plus" factory, 48 metres on the southern side, bounded by "Kaleidoscope Paints" factory, 32.3 metres on the eastern side, bounded by El Socorro Extension Road and 21.5 metres on the western side, bounded by "Furniture Plus" factory.
