APPOINTMENT OF COMMISSION OF ENQUIRY INTO THE CIRCUMSTANCES SURROUNDING THE CONSTRUCTION OF THE BICHE HIGH SCHOOL ON THE PRESENT SITE

IN ACCORDANCE with section 15 of the Commissions of Enquiry Act, Chap. 19:01 of the Laws of the Republic of Trinidad and Tobago, it is hereby notified for general information that His Excellency the President, in exercise of the powers vested in him under section 2 of the said Act, has issued a Commission, appointing MADAME JUSTICE ANNESTINE SEALEY as Commissioner:

(a) to enquire into:

- (i) the entire process which led to the construction of the Biche High School and all other acts, matters or decisions done or undertaken incidental thereto up to the present time;
- (ii) the advice and reports which were made available to the Government and/or the relevant Ministers of Government concerning the suitability or unsuitability of the site for the construction of the said school;
- (iii) the consideration, if any, given by the Government and/or the relevant Ministers of Government of the said advice and reports and the action, if any, taken by the Government or the relevant Ministers of Government in respect of the said advice and reports;

(b) to make such observations and recommendations arising out of its deliberations as the Commission may deem appropriate.
