ELECTION OF PRESIDENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO

IN ACCORDANCE with section 26 of the Constitution of the Republic of Trinidad and Tobago, it is hereby announced that an election for the President of the Republic of Trinidad and Tobago shall be held on Friday the 15th day of February, 2002.

A meeting of the Electoral College, established under section 28 of the Constitution of the Republic of Trinidad and Tobago, shall be convened on the said 15th day of February, 2002 when a President of the Republic of Trinidad and Tobago shall be elected.

A person shall not be a candidate for election as President of the Republic of Trinidad and Tobago unless nominated for election by a nomination paper which—

- (a) is signed by the candidate and by twelve or more members of the House of Representatives; and
- (b) is delivered to the Speaker at least seven days before the election.
