IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Kawanhar Doopan, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage, pending consolidation for export, of the following goods, as shall be deposited by or in the Customs Area of Messrs.
