APPOINTMENT OF A CUSTOMS AREA (Customs Act, Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Earl F. Clement, Acting Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the Customs Area of Messrs. Skyline Freight Management Limited of McDonald Street, Woodbrook, Port-of-Spain—Goods for consolidation ex-warehouse and Transhipment Cargo and such other goods as I may subsequently approve.

SCHEDULE

The dimensions of the area are 9.14 metres x 5.18 metres (Secured Area) and 9.14 metres x 6.10 metres (Holding Area) with a total area of 103.10 square metres. It is located on the ground floor of a concrete building with steel structure and a roof of galvanized sheets situate at 30, McDonald Street, Woodbrook, Port-of-Spain.

The building is bounded on the east by an open yard belonging to Skyline Freight Management Limited, to the west by Jenmar Business Machines Limited, to the south by McDonald Street and to the north by Messrs. Gormandy and Company Limited.
