

(54) Title: PROCESS FOR THERMAL TREATMENT OF GRANULAR IRON ORE BEFORE REDUCTION

(57)Abstract: The wet granulated iron ore is initially conducted through a drying zone. The ore leaves the drying zone at a temperature of 120–400° C. The ore is then heated in direct contact with hot gas to temperatures of 700–1,100° C before being delivered to a reduction zone. The ore coming out of the drying zone is fully or partially guided through a separating device so as to separate the ore into fine and coarse grain fractions. The fine–grained ore fraction is conveyed to a granulating device so as to produce an iron ore granulate which is conducted to the drying zone. The coarse–grained ore fraction is heated to temperatures of 700–1,100° C before it is guided into the reduction zone.



(54) Title: METHOD FOR SMELTING FINE GRAINED DIRECT REDUCED IRON IN AN ELECTRIC ARC FURNACE

(57)Abstract: According to the invention, direct reduced iron of at least 80 wt. % and having a maximum grain size of 3 mm is smelted in an electric arc furnace. The furnace contains a bath comprised of liquid iron. During operation of the furnace, a foamed slag layer forms on the bath. The direct reduced iron falls into the foamed slag layer and onto the iron bath through at least one movable lance by means of gravitational force. The distance of the lance opening from the iron bath is preferably maintained in an approximately constant manner.



(57)Abstract: This invention concerns a unitary system for export of liquid natural gas (LNG) from a floating production vessel (FPSO vessel) (1), with the new and inventive consists of the combination of the following points: an LNG buffer tank in the FPSO vessel, with buffer storage capacity for temporary storage of the continuous produced LNG during an LNG tank vessel's absence, a mooring device arranged for short separation moorage between the FPSO vessel's stern and an LNG tank vessel's bow, a cryogenic transfer device arranged between the



(54) Title: GASIFICATION REACTOR APPARATUS

(57)Abstract: A gasification reactor apparatus (10) comprising a gasification vessel (12), a gas-fired combustion chamber (70) and a combination fan and cyclone unit (20) in an upper part (12') of the vessel (12) with two functions: first, the fan (62, 64) impels incoming feedstock (14, 14') centrifugally into contact with the hot inside surface of the vessel to produce rapid onset of gasification. Second, the unit (20) exerts a cyclonic motion on the product gas causing outward separation of particulate matter from the gas, which passes to the outlet via a path through the middle of the vessel (12).



- (54) Title: COUPLING SLEEVE FOR HIGH-PRESSURE PIPE

(57) Abstract: A coupling sleeve (4) for connecting to at least one pipe section (2, 3) fitted in an insertion end (29) thereof comprises an inner bush (5) made of thermoplastic material and an outer bush (6), in which inner bush resistance wires are accommodated, which resistance wires (7) can be connected to an electric power source for melting the surfaces of the coupling sleeve which face each other and those of each pipe section, in order to create a welded joint, which inner bush and outer bush in axial section have parts (8, 9) which mesh with each other, in order to transmit axial and/or tangential forces. The inner bush has at least one part with a flank which faces the insertion end and which in an axial plane is determined by a tangent forming an angle of less than 45 with the axis of the inner bush.

(54) Title: PROCESS FOR PREPARING MELAMINE

(57)Abstract: The invention relates to a method of producing melamine. According to the inventive method, the NH₃ containing melamine melt that is discharged from a melamine high-pressure reactor is expanded in a fluidized bed reactor that is substantially operated with NH₃ as the process gas, optionally after separation of the off gases, aging and cooling the melt. The melt is cooled with solid melamine or solid inert substances and solidified. Cold NH₃, preferably liquid NH₃ is added to the process gas that is optionally pre-treated by means of cyclones and/or filters to purify it, thereby allowing the precipitation of solid melamine.



(54) Title: METHOD FOR REMOVING COARSE–GRAINED SOLIDS FROM A STATIONARY FLUIDIZED BED

(57)Abstract: According to the invention, a fluidizing gas is introduced upwards into the fluidized bed (3) through a valve grid (2), said stationary fluidized bed (3) containing solids with different grain sizes. A supply pipe (10) is disposed in the area of the fluidized bed, the mouth of said pipe being located above the valve grid (2) and its outlet (12) leading outwards from the fluidized bed (3). Part of the solids located above the valve grid (2) is blown into the supply pipe by a gas jet (13) which is directed upwards and fed separately from the fluidizing gas and pneumatically evacuated from the fluidized bed through the supply pipe (10). Normally, the flow speed of the gas in the supply pipe is at least two times higher than the speed of the fluidizing gas in the fluidized bed.



APPLICATION FOR A PIPELINE LICENCE BY BHP BILLITON (TRINIDAD 2C) LIMITED

PURSUANT to section 7 of the Petroleum Act, Chap. 62:01, notice is hereby given that an application for a pipeline licence has been made by BHP Billiton (Trinidad 2C) Limited to construct, install, maintain and operate a pipeline as described in the attached schedule along the route indicated in the attached map marked "A".

Any person may object to the issue of the above-mentioned licence on the ground that it is inconsistent with, or would interfere with, rights held by him under the Petroleum Act, Chap. 62:01.

All objections to the grant of the Pipeline Licence to the afore-mentioned applicant may be lodged with the Minister of Energy and Energy Industries within thirty days (30) days of the date hereof at Government Offices, Riverside Plaza, Level 9, Besson Street, Port-of-Spain.

SCHEDULE ABOVE REFERRED TO—DESCRIPTION OF PIPELINE

Route

The 457.2 mm (18-inch) liquid pipeline commences at landfall La Brea Village, Mayaro-Guayaguayare Road and passes through undulating secondary forested terrain. It then crosses the existing 152.4 mm (6-inch) bpTT and 254.0 mm (10-inch) Petrotrin pipelines. The pipeline continues 6.4 m (21 feet) south of the existing 154.2 mm (6-inch) bpTT condensate pipeline until it crosses in a NW direction below the existing 154.2 mm (6-inch) bpTT and 254.0 mm (10-inch) Petrotrin pipelines to pass 6.4 m (21 feet) north of the 254.0 mm (10-inch) Petrotrin pipeline.

The route continues north of the existing 254.0 mm (10-inch) Petrotrin pipeline and exits the forest at Schoeners Road passing beneath the road and some 152.4 mm (6-inch) existing above-ground Petrotrin pipelines. The 457.2 mm (18-inch) pipeline then crosses Schoeners Road again below the 152.4 mm (6-inch) Petrotrin above-ground pipelines and the buried Petrotrin 254.0 mm (10-inch) oil pipeline and continues until it crosses the existing 152.4 mm (6-inch) bpTT condensate pipeline. The route continues at a 6.4 m (21 feet) offset from bpTT 152.4 mm (6-inch) condensate pipeline in the Petrotrin facility then turns towards a proposed 914.4 mm (36-inch) NGC ROW. The pipeline then joins the proposed 914.4 mm (36-inch) NGC ROW passing parallel to it then below the proposed 914.4 mm (36-inch) NGC pipeline before crossing Rust Road. Immediately after the Rust Road crossing the route passes below the 1016.0 mm (40-inch) and 1219.2 mm (48-inch) bpTT pipelines to terminate in the Rust Road terminal at the 457.2 mm (18-inch) pig trap. 
