**THE DE-LISTING OF LIFE OF BARBADOS LIMITED**


**[ Pursuant to section 45(1) of the Securities Industry Act, 1995]**

**WHEREAS:**

- (1) The shares of Life of Barbados Limited were admitted for quotation on the Trinidad and Tobago Stock Exchange on the 8<sup>th</sup> day of January, 1997;
- (2) On the 8<sup>th</sup> day of March, 2002 Barbados Mutual Life Assurance Society (now called Sagicor Financial Corporation and hereinafter referred to as "the company") made a mandatory offer to acquire all of the issued common shares of Life of Barbados Limited not already owned by it. As at the date of the offer the company beneficially owned or exercised control or direction over 10,558, 817 common shares of Life of Barbados Limited;
- (3) On the 24th day of June, 2002 the company acquired 95% of the remaining issued common shares of Life of Barbados Limited;
- (4) On the said 23<sup>rd</sup> day of July, 2002, the company invoked the provisions of section 186 of the Companies Act Cap 308 of the Laws of Barbados to compulsorily acquire all of the remaining shares of Life of Barbados Limited;
- (5) On the 23<sup>rd</sup> day of July, 2002 the company served notices on the dissenting offerees that it had received acceptances in excess of 90% of the shares to which the mandatory offer related and that the Company had taken up and paid for the shares of the offerees who accepted the offer and advised dissenting offerees that they were required to elect to either transfer their shares to the company on the terms on which the company acquired the shares of the accepting offerees or demand fair payment for their shares in accordance with sections 193-196 of the Companies Act Cap 308;
- (6) On the 21<sup>st</sup> day of August, 2002 the company sent notices pursuant to section 192 of the Companies Act Cap 308 to dissenting offerees advising them of the cancellation of their shares in Life of Barbados Limited as a result of the compulsory acquisition of the shares by the company;
- (7) Life of Barbados Limited, by letter dated January 17, 2003, requested the Trinidad and Tobago Stock Exchange Limited to de-list its shares;
- (8) Section 45(1) of the Securities Industry Act, 1995 provides that no self-regulatory organization shall de-list a security admitted for quotation by it, unless it obtains an order from the Commission authorizing the de-listing;

Now therefore, in exercise of the power conferred by section 45(1) of the Securities Industry Act, 1995, the Trinidad and Tobago Securities and Exchange Commission hereby authorizes the de-listing of the shares Life of Barbados Limited from the Trinidad and Tobago Stock Exchange.
