## APPOINTMENT OF A CUSTOMS AREA

(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Joseph A. Renaud, Acting Comptroller of Customs and Excise, acting under the provisions of section 2 and 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other ingredients imported or taken out of Bond by Taste Maker Manufacturing Company Limited for the manufacture of Essences, Flavouring Extracts, Food Colours and Preservatives or other goods as may subsequently be approved.

### SCHEDULE

An area measuring 7.3 metres by 3 metres constructed of walls of concrete 2.718 metres high with a concrete roof and secured by a steel door, framed within the concrete wall on the western side, situated on the north-eastern corner of the Ground Floor of Taste Maker Manufacturing Company Limited at Bhagoutie Trace, San Juan.
