### INTRODUCTION OF PRIVATE BILL

#### AN ACT FOR THE INCORPORATION OF THE NATIONAL CARNIVAL BANDS ASSOCIATION OF TRINIDAD AND TOBAGO ASSOCIATION

1. Public notice is hereby given in accordance with standing Order No. 83(3)(b)(i) of the House of Representatives that it is intended to introduce in the House of Representatives the above-mentioned Bill.

2. Notice of the intended introduction of the Bill is given in the *Trinidad and Tobago Gazette* and copies of the Bill may be purchased from the Government Printer.

3. The object of the Bill, among other things, is to incorporate the National Carnival Bands Association of the Grand Stand, Queen's Park Savannah, Port-of-Spain in order to enable or to hold property and to otherwise carry out its aims and objectives.
