2004 CONSOLIDATED INDEX
OF THE
ACTS AND SUBSIDIARY LEGISLATION OF TRINIDAD AND TOBAGO

The Law Revision Commission has released the publication of the 2004 CONSOLIDATED INDEX OF THE ACTS AND SUBSIDIARY LEGISLATION OF TRINIDAD AND TOBAGO.

GENERAL

This Index is of special importance to Attorneys-at-Law and Accountants.

An Attorney-at-law would find the Index an invaluable aid in identifying the Acts published in the 1980 Revised Edition (as updated by the First and Second Supplements) and those Acts that are omitted therefrom and also the amendments made to those published and omitted Acts up to **December 31, 2003**.

The Index would also assist the Accountant in identifying the Taxation Legislation of Trinidad and Tobago (e.g., Income Tax Act, Corporation Tax Act, Value Added Tax Act, Miscellaneous Taxes Act, etc.; and the amendments made thereto up to the December 31, 2003.

The Index is also of special importance for updating and annotating (a) the laws published in the 1980 Revised Edition (as updated by Supplements) and (b) the Acts and Subsidiary Legislation published in the Annual Volumes for the years 1978 to 2003.

BASIC FEATURES OF THE INDEX

The Index is divided into two Parts – Part I and Part II.

Part I of the index contains the following information:

- (a) Acts which are in force on **January 1, 2004**, save where otherwise indicated, and the Subsidiary Legislation made under those Acts.
- (b) Acts and Subsidiary Legislation contained in Volumes I to XVI of the 1980 Revised Edition (as updated by Supplements) and the amendments made thereto up to **December 31, 2003**.
- (c) The Acts and Subsidiary Legislation authorized by the Law Revision (Omission of Acts) Order 1990 (LN 234/1990) to be omitted from the Revised Edition but which nonetheless remain in force as extant laws of Trinidad and Tobago.
- (d) The Acts and Subsidiary Legislation published in the Annual Volumes for years 1978 to 2003.

Part II of the Index contains the titles of Statutes which are repealed or spent between January 1978 and December 31, 2003 together with the references to the laws by which they were repealed. (*References to amendments to these Acts and Subsidiary Legislation made under them are contained in previous Indexes*).
