APPOINTMENT OF A PRIVATE EXCISE WAREHOUSE

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under section 3, of the Excise General Provisions Act, Chap. 78:50, I, Joseph Renaud, Acting Comptroller of Customs and Excise, do hereby appoint the place specified in the Schedule hereunder to be a Private Bonded Excise Warehouse for the storage of Spirits and Spirits Compounds by Trinidad Distillers Limited on premises situate at the Corner of Eastern Main Road and Trinity Avenue, Laventille.

SCHEDULE

- (1) An enclosed warehouse measuring approximately 21 metres on the northern side, 21 metres on the southern side, 34.48 metres on the eastern side and 34.48 metres on the western side.
- (2) The approximate total area of the Warehouse is 734 sq. metres.
- (3) The building is constructed on concrete floors and walls, steel beams and a galvanized roof.
- (4) The building is commonly known as Trinidad Distillers Limited (Coates Threads) Warehouse No. 10.
- (5) The building is located south of Telecommunications Services of Trinidad & Tobago Limited, Laventille Work Centre, approximately 97.5 metres south of the Eastern Main Road and 60 metres north of the Priority Bus Route.
- (6) The building is bounded on the north by Telecommunications Services of Trinidad & Tobago Limited, on the south by lands belonging to Trinidad Distillers Limited, on the east by Trinidad Distillers Limited Warehouse No. 8, and on the west by Telecommunications Services of Trinidad & Tobago Limited Car Park.
