REVOCATION OF APPOINTMENT OF A PRIVATE WAREHOUSE (*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Frederick Lewis, Acting Comptroller of Customs and Excise, do hereby revoke the appointment of the place described in the Schedule hereunder as a Private Warehouse, which said place was appointed a Private Warehouse, by the Comptroller of Customs and Excise for the warehousing of certain goods by Messrs. H. E. Robinson Enterprises Limited, under the provisions of section 263(2) of the Customs Act, Chap. 78:01 and which said appointment was published as Notice No. 2627, dated 13th December, 1993 in the *Trinidad and Tobago Gazette*.

SCHEDULE

A warehouse "L" shaped of two longer sides measuring 33.9 metres by 20.5 metres and two shorter sides measuring 12.25 metres comprising 930.76 square metres and located at Old Southern Main Road, Curepe.

It is constructed of concrete blocks on the eastern, the western and the southern sides and steel bars on the northern side.

The entire building is covered with galvanized iron sheets. The warehouse forms part of the building of H. E. Robinson Enterprises Limited to the east and bounded on the west by Kay Donna Drive-in Cinema, bounded on the north by the Old Southern Main Road and on the South by the N.U.G.F.W. Housing Settlement.
