## APPOINTMENT OF A CUSTOMS AREA

(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Joseph Renaud, Acting Comptroller of Customs and Excise, acting under the provisions of section 2 of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area for the storage of machinery, equipment, raw materials, semi-manufactured goods and other goods, as may be subsequently approved or imported or taken out of Bond by Triclean Odor Control Systems and Supplies on premises situate at Spring Village, Balmain, Couva, for the manufacture of Industrial Wiping Rags.
