## VACANCIES TO ACT AS PUISNE JUDGES OF THE HIGH COURT

THE JUDICIAL AND LEGAL SERVICE COMMISSION proposes to advise the President of the Republic of Trinidad and Tobago to appoint three persons to act as Puisne Judges of the High Court pursuant to section 104(2)(d)(i) of the Constitution of Trinidad and Tobago, to deal with the backlog of matters under the old Rules of the Judiciary.
