TENDERS FOR PRE-QUALIFICATION OF CONSULTING FIRMS TO PROVIDE SERVICES FOR THE PUBLIC SECTOR REFORM INITIATION PROGRAMME (PSRIP), MINISTRY OF PUBLIC ADMINISTRATION AND INFORMATION

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) through the Ministry of Public Administration and Information (MPAI) has accessed loan funding from the Inter-American Development Bank (IDB) for a Public Sector Reform Initiation Programme (PSRIP) UDB Loan No. 1523/OC-TT. The General objective of the Programme is to support the initial development and implementation of a long-term strategy to reform the Public Sector in order to meet the national goal of achieving developed country status by the year 2020.

Applications are invited from international and local consulting firms to pre-qualify for the undermentioned consultancies under the PSRIP—

- (1) Study for the identification of issues and policy options.
- (2) Development and implementation of the first phase of a national dialogue strategy.
- (3) Development and implementation of a communication strategy.

Consulting firms are required to submit a separate application for each consultancy.

Applications will be evaluated in accordance with the following criteria:

- Eligibility
- Experience
- Financial situation
- History of contract non-performance

The pre-qualification will determine three (3) short-lists of a maximum of six (6) firms each to be invited to submit proposals to provide services for the projects identified above.
