- 2. Supervises support staff employed in the Court.
- 3. Participates in preparing, developing and formulating the annual budget of the Industrial Court and defending it before the Ministries of Finance and Planning and Development.
- 4. Keeps the official seal of the Industrial Court and affixes it to documents as required by law or as may be directed by the Court.
- 5. Ensures the safe keeping of all records and documents belonging to the Court and acts as custodian of all such records.
- 6. Performs administrative duties relative to the efficient operation of the Industrial Court, South Office which includes:

Monitoring and directing the entry into registers, of proceeding before the Industrial Court, San Fernando, collective agreements and memoranda of agreement submitted to the said Court to ensure that information is entered accurately and within given time frames.

- 7. Participates in strategic planning for the organization and ensures the implementation of policies and procedures of the Industrial Court.
- 8. Prepares Notes for Cabinet.

#### Judicial and Legal (60%)

- 1. Signs and issues notices and summonses, prepares court lists and taxes cost and issues certificates for recovery of compensation or damage.
- 2. Draws up orders of the court and ensures the preparation of all proceedings for hearing and the publication and dissemination of judgments and relevant announcements of the Court.
- 3. Examines collective agreements to ensure compliance with the relevant Industrial Relations Act, Chap. 88:01 and in cases where there are infringements, summons the respective parties for hearing.
- 4. Files proceedings with the registry of the High Court of Justice for the recovery of fines, damages and compensation in accordance with the relevant section of the Industrial Relations Act, Chap. 88:01.
- 5. Interviews representatives of labour and management and advises them on the practice and procedure/s for the referral and determination of disputes, differences, industrial relations offences, applications for interpretation or injunction, appeals against judgments and other similar and related matters.
- 6. Occasionally presides over hearings relating to the status of trade disputes and/or applications referred to the Industrial Court for determination.
