**THE CARIBBEAN COURT OF JUSTICE (ORIGINAL JURISDICTION) (AMENDMENT) RULES,
2006**

1. These rules may be cited as the Caribbean Court of Justice (Original Jurisdiction) (Amendment) Rules, 2006 and shall come into force on the 14th July, 2006.
2. (1) The Caribbean Court of Justice (Original Jurisdiction) Rules 2006 are hereby amended as set out in the Schedule.
(2) Column I of the Schedule sets out the rules amended, Column II of the Schedule describes the amendment of the rule and Column III of the Schedule sets out the rule as amended.
