PROVISION OF CONSULTANCY SERVICES FOR THE DELIVERY OF A TRAINING PROGRAMME FOR AVIATION SECURITY PERSONNEL IN PASSENGER PROFILING—CIVIL AVIATION AUTHORITY—IDB/MIF NON REIMBURSABLE TECHNICAL CO-OPERATION AGREEMENT—NO. ATN/MT 8045—TT (STRENGTHENING OF AIRPORT SECURITY)

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO has signed a Non Reimbursable Technical Co-operation Agreement with the Inter-American Development Bank (IDB) with a view to upgrading and enhancing the aviation security systems and processes through:

- (1) The training of members of staff of the Trinidad and Tobago Civil Aviation Authority (TCAA), the Airports Authority of Trinidad and Tobago (AATT) and other key personnel in other related agencies in all aspects of aviation security and procedures using International Civil Aviation Organization (ICAO) standards.
- (2) The development of a continuous learning environment for all aviation security personnel through the maintenance of in-house training personnel equipped with the latest ICAO manuals and procedures.

The Central Tenders Board now invites sealed proposals from eligible individuals of member countries (IDB/MIF) for the provision of consultancy services for the delivery of a training programme for Aviation Security Personnel in Passenger Profiling for the Trinidad and Tobago Civil Aviation Authority.
