# APPOINTMENT OF A PRIVATE WAREHOUSE CUSTOMS AREA (Customs Act. Chap. 78:01)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto, to be a private warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs: Lifestyle Motors Limited, Corner Churchill-Roosevelt Highway (South) and Bhagoutie Trace, San Juan—four (make) (model) motor vehicles and any such goods as I may subsequently approve.

#### SCHEDULE

- (i) An enclosed area measuring 9.75 metres long and 2.4 metres wide comprising 23.4 square metres situated in the north-western corner of the building.
- (ii) The building is constructed of concrete floors, glass, roof and steel beams.
- (iii) The building is bounded on the north by Ibis Avenue, on the south by the Churchill-Roosevelt Highway, on the east by an empty piece of land owned by Mrs. B. Jogie, and on the west by a car park owned by Lifestyle Motors Limited.
- (iv) Entrance is gained through a glass door on the western side of the said building.
