IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Private Warehouse for the storage, pending entry for home consumption or export, of the following goods, as shall be warehoused by or in the private warehouse of Messrs. Micon Marketing Limited, Warehouse No. 23, Fernandes Industrial Compound, Eastern Main Road, Laventille, viz., Cell Phones and Accessories, and such other goods as I may subsequently approve.

#### Schedule

The building is bounded on the east by property occupied by the Trinidad and Tobago Electricity Commission, the west by Warehouse No. 22, the north by the Priority Bus Route, and the south by Warehouse No. 10.
