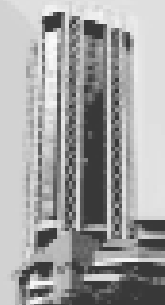

# NOTICE OF REQUIREMENTS



*(Insurance Act Chap. 84:01)*

NOTICE is hereby given in accordance with paragraph 5(2) of the Second Schedule of the Insurance Act Chap. 84:01 that a registered pension fund plan which has a total accepted value of assets in excess of one hundred and fifty per cent of its total liabilities may invest in ordinary shares up to the limit specified in paragraph 5(2) of the Second Schedule of the Insurance Act Chap. 84:01 ("Act") provided that such registered pension fund plan ("pension plan") has satisfied the Central Bank of Trinidad and Tobago ("Central Bank") that it:

- (i) has implemented an investment policy in accordance with the Central Bank's Guideline issued in May 2005 entitled the "Prudent Person Approach to Investment and Lending";
- (ii) has submitted a quarterly balance sheet in the spreadsheet format specified by the Central Bank for semi annual reporting by pension plans;
- (iii) has submitted the most recent actuarial investigation into the financial condition of the pension plan as required under Section 185 of the Act to the Central Bank within the nine month period specified under Section 61(2)(b) of the Act;
- (iv) has complied with the requirements of the Insurance Act and the Regulations made thereunder and any applicable guidelines issued by the Central Bank;
- (v) has submitted on an annual basis, an actuarial certificate of the pension liabilities. The determination of the total pension liabilities will be based on the assumptions used in the latest actuarial investigation conducted under Section 185 of the Act, and on the most current membership information at the disposal of the actuary. In this regard, the membership data used for the most recent determination of the IAS19 pension liability would be accepted.
