The HSF, which is denominated in US dollars, is not part of the Central Bank's foreign exchange reserves. The provision of the foreign exchange for this Fund led to an amendment to the original accounts published for the Central Bank of Trinidad and Tobago for the period 15th March, 2007 to 27th August, 2008".
