TENDER FOR THE REMOVAL AND DISPOSAL OF EXISTING UNDERGROUND FUEL TANKS AND SUPPLY, DELIVERY AND INSTALLATION OF REPLACEMENTS FOR THE TRINIDAD AND TOBAGO FIRE SERVICE, MINISTRY OF NATIONAL SECURITY

TENDERS are invited for the removal and disposal of existing underground fuel tanks and supply, delivery and installation of replacements for the Trinidad and Tobago Fire Service, Ministry of National Security as follows:

- (a) three (3) underground fuel tanks (2 diesel, 1 gasoline) at Trinidad and Tobago Fire Service Headquarters, Wrightson Road, Port-of-Spain;
- (b) three (3) underground fuel tanks (2 diesel, 1 gasoline) at Trinidad and Tobago Fire Service Divisional Headquarters, Biljah Road, Chaguanas.

- (c) National Insurance Compliance Certificate issued in accordance with the National Insurance Act.

Sealed tenders in duplicate will be received up to 1.00 p.m. on Thursday 27th November, 2008. Envelopes must be addressed to the Chairman, Central Tenders Board, 116, Frederick Street, Port-of-Spain and marked on the outside: "Tender for the removal and disposal of existing underground fuel tanks and supply, delivery and installation of replacements for the Trinidad and Tobago Fire Service, Ministry of National Security" and must be deposited in the Brown Tenders Box located in the lobby of the Board's Office.
