TENDERS are invited for the Construction of the New San Juan Market Complex at First and Second Streets, San Juan, for the Ministry of Local Government.

A site visit is scheduled for Thursday 17th April, 2008 at 10.00 a.m. A pre-tender meeting will follow at the San Juan/Laventille Regional Corporation, MTS Plaza, Aranguez.

Tenderers are required to pay a tender deposit of two thousand dollars (\$2,000.00) payable by cash or certified cheque to the Director of Contracts and attach the original receipt to their tender. This tender deposit will be received between the hours of 8.30 a.m. to 12.00 noon and 1.00 p.m. to 2.00 p.m. on Mondays to Fridays.

Tenders must be accompanied by the following:

- (i) valid Income Tax and Value Added Tax Clearance Certificates issued by the Board of Inland Revenue and dated not more than six (6) months prior to the closing date of the tender;
- (ii) a valid Certificate of Compliance issued in accordance with the National Insurance Act.
