**Explanatory Note**

(These notes form no part of the Bill but are intended only to indicate its general purport)

The object of the Bill is to supplement the appropriation provided for by the Appropriation Act, 2008, as amended by the Finance (Supplementation and Variation of Appropriation) Act, No. 7 of 2008 respectively, by authorizing the issue from the Consolidated Fund in the sum of Three Thousand, Nine Hundred Million Dollars (\$3,900,000,000).

Short title **1.** This Act may be cited as the Finance (Supplementary Appropriation) Act, 2008.

Further issue of \$3,900,000,000 from the Consolidated Fund **2.** A further issue from the Consolidated Fund in the sum of three thousand, nine hundred million dollars is authorized for meeting expenditure for the service of the financial year ending September 30, 2008 and appropriated in respect of the Head of Expenditure set out in the Schedule.
