#### ORDER OF THE COMMISSION

WHEREAS Trinidad Select Index Fund Limited ("the Respondent") failed to file its 2009 Interim Financial Statement with the Commission on or before 29th November, 2009;

And whereas by Notice of Contravention S.I. No. 30 of 2010 dated 28th April, 2010, the Commission advised the Respondent that it was in contravention of section 66(2) of the Securities Industry Act, 1995 ("the Act") and By-Law 55(1) of the By-Laws by failing to file a copy of its 2009 Interim Financial Statement with the Commission on or before 29th November, 2009;

And whereas by e-mails dated 6th May and 17th May, 2010, the Staff of the Commission and the Respondent entered into settlement discussions to determine whether the matter could be settled;

And whereas on the 2nd day of June, 2010, the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the Commission and the Company Secretary on behalf of the Respondent ("the Settlement Agreement"), in which the parties agreed to a settlement, subject to the approval of the Settlement Panel;

And whereas the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission;

And whereas the Respondent has agreed to pay the sum of twenty thousand dollars (\$20,000.00) to the Commission;

And whereas the Commission has considered the Settlement Agreement and is of the opinion that it is in the public interest to make this Order.

It is hereby ordered that:

- (a) The procedure outlined under the Securities Industry (Hearing and Settlements) Practice Rules, 2008 has been followed;
- (b) The Respondent has contravened section 66(2) of the Act and By-Law 55(1) of the By-Laws and that pursuant to section 143(1) of the Act, that the Respondent pay to the Commission, as agent for the Comptroller of Accounts, a fine in the sum of \$20,000.00 for the contravention, within 28 days of the date on which this Order is entered; and
- (c) This Order shall be published in the Trinidad and Tobago Gazette and in the daily newspapers.
