PETITION

The Petition of DIALLO JOHN of 92, La Horquette Valley Road, Glencoe, in the island of Trinidad, shows that:

- (1) The Petitioner DIALLO JOHN is a person who voted and who had a right to vote at the local government election for the Region of Diego Martin.
- (2) The said election as held on the 26th July, 2010 when ENA ADDLY and SUSAN RODRIGUEZ (the Respondent) were candidates for the electoral district of Belle Vue/Boissierre No. 1, in the electoral area of Diego Martin, as defined at Part II, Schedule 1, of the Elections and Boundaries (Local Government) Act, Chap. 25:50 of the Laws of Trinidad and Tobago, and on 27th July, 2010 the Returning Officer declared that the Respondent received 1,248 votes and the said ENA ADDLY received 1,135 votes and the Respondent was declared as being duly elected.
- (3) This Petition is presented within 8 days of 3rd August, 2010, such date being the seventh day next following the date on which the Returning Officer declared the result of the poll of the electoral district of Belle Vue/Boissierre No. 1, in the electoral area of Diego Martin as the Returning Officer was required to do by Rule 108(1) of the Election Rules.

Disqualification for election

- (4) The said SUSAN RODRIGUEZ is and was at all material times registered as being resident and resident at 44, Misty Crescent, Sunrise Park, Trincity, in the Island of Trinidad, which is in the electoral area of Tunapuna/Piarco, as defined at Part II, Schedule 1, of the Elections and Boundaries (Local Government) Act, Chap. 25:50 of the Laws of Trinidad and Tobago, and pursuant to section 11 of the Municipal Corporations Act, Chap. 25:04 was accordingly not qualified to be a candidate for the election for the electoral district of Belle Vue/Boissierre No. 1, in the electoral area of Diego Martin, as defined at Part II, Schedule 1, of the Elections and Boundaries (Local Government) Act, Chap. 25:50 of the Laws of Trinidad and Tobago.

The Petitioner therefore prays:

1. That a declaration be given that the Respondent is and was disqualified and not qualified to be a candidate and/or to be elected and that her return upon the final count was in any event unlawful.
2. That it may be determined that the Respondent was not duly elected and that the election of the Respondent was void;
3. That it may be determined that the candidate ENA ADDLY was duly elected and ought to have been returned;
4. That the Petitioner may have such further or other relief the court thinks just.

ORDER OF THE COMMISSION

WHEREAS Mora Ven Holdings Limited ("the Respondent") filed a copy of its 2009 Amended Registration Statement with the Commission on 6th November, 2009, past the due date of 27th October, 2009;

And whereas by Notice of Contravention S.I. No. 27 of 2010 dated 28th April, 2010, the Commission advised the Respondent that it was in contravention of section 64(3) of the Securities Industry Act, 1995 ("the Act") by filing a copy of its 2009 Amended Registration Statement with the Commission on 6th November, 2009, past the due date of 27th October, 2009;

And whereas by letter dated 12th May, 2010 the Staff of Commission and the Respondent entered into settlement discussions to determine whether the matter could be settled;

And whereas on the 8th day of July, 2010 the Respondent entered into a proposed settlement agreement with the Staff of the Commission which was signed by the duly authorized representative of the Commission and the Corporate Secretary of the Respondent ("the Settlement Agreement"), in which the parties agreed to a settlement, subject to the approval of the Settlement Panel;

And whereas the Settlement Panel approved the Settlement Agreement and agreed to submit the Settlement Agreement to the Commission;

And whereas the Respondent has agreed to pay the sum of five thousand dollars (\$5,000.00) to the Commission;

And whereas the Commission has considered the Settlement Agreement and is of the opinion that it is in the public interest to make this Order.

It is hereby ordered that—

- (a) The procedure outlined under the Securities Industry (Hearing and Settlements) Practice Rules, 2008 has been followed;
- (b) The Respondent has contravened section 64(3) of the Act and that the Respondent pay to the Commission, as agent for the Comptroller of Accounts, a fine in the sum of \$5,000.00 for the contravention, within 28 days of the date on which this Order is entered; and
- (c) This Order shall be published in the *Trinidad and Tobago Gazette* and in the daily newspapers.
