  - (a) The purchase price payable to the Port Authority.
  - (b) Customs Duty equivalent to thirty (30%) per cent of the sale price shall be payable at Customs House.
  - (c) Any taxes or duties chargeable under any law other than duty imposed under the Customs Act calculated by reference to the purchase price.
- (3) Payment must be made to the Port Authority on the fall of the hammer either by cash or certified cheque. Debit/Credit cards will be accepted.
- (4) Persons failing to comply with condition (3) above will be debarred from further participating in Auction Sales held by the Port Authority.
