#### CARNIVAL 2010—PUBLIC NOTICE

- 1. The attention of the public is drawn to the—
  - (a) Public Festivals (Carnival) Order, 2010, made by the President, dated the 27th day of January, 2010, declaring the period of Carnival in respect of the year 2010; and
  - (b) Carnival Regulations, 2010 (referred to in this Notice as "the said Regulations"),

both of which are published as Supplements to the "Trinidad and Tobago Gazette", Vol. 47, No. 7, dated the 17th day of January, 2010, (Legal Notice Nos. 15 and 14 respectively).

- 2. The attention of the public is also drawn to the-
  - (a) several Traffic Notices published in the *Gazette* and in the daily newspapers in circulation in Trinidad and Tobago, containing Orders regulating the use of the roads during Carnival; and
  - (b) the provisions of section 5 of the Public Holidays and Festivals Act, Chap. 19:05, and regulation 2(1)(a)(i), (d) and (m) of the Carnival Regulations.
- 3. The Public is advised that-
  - (a) section 5(5), (8), (9), (10) and (11) of the Public holidays and Festivals Act, reads as follows:
    - "(5) Any person who appears in public masked or otherwise disguised except during a public festival at which he is authorized to do so by Regulations under subsection (2) is liable to a fine of one thousand dollars and to imprisonment for six months.
    - (8) If during a specified festival any person has with him in any public place any article which by virtue of Regulations made under subsection (2) he is prohibited from so having, any member of the Police Service may, if he considers it expedient to do so, without proceeding to arrest such person, seize and take away such article. All articles seized under this subsection shall be forfeited and shall be kept in safe custody by the police until disposed of in suchmanner as the Minister may direct.
    - (9) If during a specified festival any person shall have with him in any public place any article which, in the opinion of a member of the Police Service, is likely to be used for causing injury to the person, such member of the Police Service, if he considers it in the interest of the safety of the public to do so, may, notwithstanding that such article does not fall within the class of articles specifically prohibited by Regulations made under subsection (2), seize and take away such article. All articles seized under this subsection shall be kept in safe custody by the Police, and if within a period of six months after the specified festival at which such articles have been seized any person establishes to the satisfaction of the Commissioner of Police a claim to any such article, the Commissioner of Police shall cause such article to be restored to such person. Nothing in this subsection shall authorize or be construed as authorizing the restoration to any person of any offensive weapon within the meaning of the Prevention of Crime (Offensive Weapons) Act, but all such offensive weapons seized under this subsection, and all other articles so seized which are not claimed within the aforesaid period of six months shall be forfeited and shall be kept in safe custody by the police until disposed of in such manner as the Minister may direct.
    - (10) Any person who refuses to deliver up any article which a member of the Police Service requires to be delivered up for seizure under subsection (8) or (9), or obstructs any member of the Police Service when acting in pursuance of any provision of the said subsections, is liable to a fine of two hundred and forty dollars and to imprisonment for six months.
      - (11) In this section—
        - (a) the expression "Police Service" shall be construed as including reference to the Supplemental Police and the Special Reserve Police established under the Supplemental Police Act and the Special Reserve Police Act, respectively;
        - (b) the expression "public place" includes any highway and any other premises or place to which at the material time the public have or are permitted to have access, whether on payment or otherwise";
  - (b) regulation 2(1)(a) (i), (d) and (m) of the Carnival Regulations, 2010 reads as follows:
    - "2. (1) No person shall—
      - (a) appear dressed—
        - (i) in the uniform prescribed for the Police Service, Special Reserve Police, Supplemental, City or Borough Police, Fire Service, Prison Service or any unit of the Defence Force unless the person is a serving member of the Police Service, Special Reserve Police, Supplemental, City or Borough Police, Fire Service, Prison Service or any unit of the Defence Force;
      - (d) smear or daub on any other person any substance, matter of thing, or with intent to intimidate or to obtain from that other person any money or valuable thing, attempt or threaten to smear or daub on that other person any substance, matter or thing;
      - (m) have in his possession or carry in any band anything resembling a firearm or ammunition".
