Support for a Seamless Education System Programme, Ministry of Education (MOE), Government of the Republic of Trinidad and Tobago (GORTT), Inter-American Development Bank (IDB) Loan 2138/OC—TT

THE GOVERNMENT OF THE REPUBLIC OF TRINIDAD AND TOBAGO (GORTT) has embarked on a Support for a Seamless Education System Programme and has received funding from the IDB towards the cost of this programme. The programme is in keeping with one of the mandates of GORTT's Strategic Plan—Vision 2020—which is to establish a world class, self-renewing, and seamless education system for Trinidad and Tobago.

Through the Support for a Seamless Education System Programme, the GORTT will ensure a well articulated and harmonized education system ranging from the early childhood care and education through the secondary levels with the linkages to the tertiary level and the world of work. The Programme will implement measures aimed at improving quality, equity and access throughout the education sector. Such measures include the conduct of an overall needs assessment for the Education Management Information System (EMIS), the Knowledge Management System (KMS) and the integration of existing databases in the Ministry of Education and the development of Terms of Reference for the design and implementation of these systems and the integration of existing databases in the Ministry of Education.

In this regard, the Central Tenders Board invites eligible consulting firms/universities to indicate their interest in providing technical assistance to facilitate the implementation of the programme in the following two (2) subject areas:
