## Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA KI MAI CELEBRATIONS) ORDER, 2010

1. This Order may be cited as the Traffic Restriction (Temporary <sub>Citation</sub> Provisions) (Siparia Ki Mai Celebrations) Order, 2010.

2. This Order has effect from 2.00 p.m. on Thursday 1st April, 2010 Duration to 12.00 noon on Friday 2nd April, 2010.

- 3. Vehicular traffic and parking are prohibited on— Vehicular
  - (a) George Street, between Edward Street and La Pastora traffic and parking prohibited
  - (b) Mary Street, between Edward Street and La Pastora Street; and
  - (c) La Pastora Street, between Victoria Street and Siparia-Erin Road.

4. Parking is prohibited on—

Parking prohibited

- (a) De Gannes Lane;
- (b) Victoria Street, between Coora Road and La Pastora Street;
- (c) Siparia Road, between Potter Lane and Siparia-Erin Road;
- (d) Edward Street, between Mary Street and Siparia-Erin Road;
- (e) Coora Road, between Mary Street and Siparia-Erin Road; and
- (f) Mary Street, between Station Street and Coora Road.

5. Between the hours of 6.00 p.m. on Thursday 1st April, 2010 and Traffic routes 2.00 a.m. on Friday 2nd April, 2010 vehicular traffic—

- (a) approaching Siparia from Erin along Siparia-Erin Road, proceeding to San Fernando, shall proceed north onto Siparia Road, east onto Gambal Street, south onto Grell Street and east onto Siparia-Erin Road; and
- (b) approaching Siparia from Fyzabad along Siparia-Erin Road, shall proceed east onto De Gannes Lane, south onto Potter Lane and back onto Siparia Road.

Removal and impounding of vehicles unlawfully parked
6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
