ORDER

Made by the Commissioner of Police under section 68(1) of THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (SIPARIA FETE) ORDER, 2010

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Siparia Fete) Order, 2010.
- 2. This Order has effect from 6.00 p.m. to midnight on Saturday Duration 24th April, 2010 and from 10.00 a.m. to midnight on Sunday 25th April, 2010.
 - 3. On Saturday 24th April, 2010—
 - Vehicular (a) vehicles shall not be permitted to enter Siparia-Erin Road prohibited and traffic diverted
 - from— (i) Edward Street;
 - (ii) Coora Road; and
 - (iii) De Gannes Lane; and
 - (b) vehicles entering Siparia from Erin proceeding to San Fernando shall be diverted—
 - (i) south onto La Pastora Street, east onto Victoria Street, north onto Allies Street and then east onto Siparia-Erin Road; or
 - (ii) north onto the Fyzabad-Oropouche Road, east onto Gambal Street, south onto Grell Street and then east onto Siparia-Erin Road.
 - 4. On Sunday 25th April, 2010—

Vehicular traffic and parking

- (a) vehicular traffic is prohibited on—
 - (i) Allies Street, between High Street and Bermudez prohibited Trace;
 - (ii) Daisy Voisin Street, between High Street and Victoria Street;
 - (iii) Coora Road, between High Street and Victoria Street:
 - (iv) Edward Street;
 - (v) High Street, between Grell Street and La Pastora Street:
 - (vi) George Street;
 - (vii) Mary Street; and
 - (viii) Station Street, between Victoria Street and Mary Street; and

- (b) parking is prohibited on—
 - (i) Grell Street;
 - (ii) Gambal Street;
 - (iii) Fyzabad-Oroupouche Road, between High Street and Gambal Street;
 - (iv) Victoria Street, between Allies Street and La Pastora Street;
 - (v) Allies Street, between Bermudez Trace and Victoria Street;
 - (vi) La Pastora Street; and
 - (vii) De Gannes Lane.

Traffic Routes 5. (1) Motorists entering Siparia from Penal shall proceed by way of Grell Street, onto Gambal Street and onto Fyzabad-Oropouche Road.

- (2) Motorists proceeding towards Penal from Siparia shall proceed by way of Fyzabad-Oropouche Road, onto Gambal Street, onto Grell Street and onto Siparia-Erin Road.
- (3) Motorists approaching Siparia from Mendez Village along Coora Road and proceeding towards San Fernando, shall turn east onto Victoria Street, onto Allies Street, onto Bermudez Trace and east onto Siparia-Erin Road.
- (4) Motorists approaching Siparia from Mendez Village along Coora Road and proceeding towards Erin, shall turn west onto Victoria Street, onto Station Street and west onto Siparia-Erin Road.

Removal and impounding of vehicles unlawfully parked 6. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
