## Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

## THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (LABOUR DAY CELEBRATIONS—FYZABAD) ORDER, 2010

1. This Order may be cited as the Traffic Restriction (Temporary <sub>Citation</sub> Provisions) (Labour Day Celebrations—Fyzabad) Order, 2010.

2. This Order shall have effect between the hours of 8.00 a.m. and Duration 10.00 p.m. on Saturday 19th June, 2010.

3. Parking is prohibited on the following:

Parking

- (a) Fyzabad-Guapo Road, between Uriah Butler Avenue and <sup>prohibited</sup> Gowers Well Road;
- (b) Easy Street, between Fyzabad-Guapo Road and Coolman Trace;
- (c) Coolman Trace, between Easy Street and Fyzabad-Guapo Road;
- (d) Fyzabad-Guapo Road, between Coolman Trace and Uriah Butler Avenue;
- (e) Lum Tack Hill;
- (f) Delhi Road, between John Jules Trace and Fyzabad-Oropouche Road;
- (g) Fyzabad-Oropouche Road, between Delhi Road and Monteil Trace;
- (h) Gowers Well Road, between Fyzabad-Guapo Road and John Jules Trace;
- (i) John Jules Trace, between Delhi Road and Gowers Well Road;
- (j) Uriah Butler Avenue from Dollar Value Supermarket to Fyzabad Police Station;
- (k) from Avocat Junction south along Fyzabad-Oropouche Main Road to Charlie King Junction; and
- (l) Fyzabad-Oropouche Road, between Lum Tack Hill and Jimdar Street.

Vehicular traffic prohibited	4. Vehicular traffic is prohibited along the Fyzabad-Guapo Road, between Uriah Butler Avenue and Charlie King Junction.
Vehicular traffic routes	<ul> <li>5. (1) Vehicular traffic approaching—</li> <li>(a) Fyzabad from Oropouche, inclusive of taxis and Public Transport Service Corporation buses shall turn left at Avocat Junction, onto Siparia Old Road, onto Fyzabad-Guapo Road and end at Fyzabad Composite School. At this point passengers will alight and disembark from vehicles;</li> <li>(b) Fyzabad from Oropouche, shall turn left at Ralph Narine Trace, left onto St. John Trace, left onto the Avocat-Siparia Old Road at the Avocat Vedic School, onto the Fyzabad-Guapo Road and end at the Fyzabad Composite School;</li> <li>(c) Fyzabad from Oropouche, shall turn right onto Berridge Trace, left onto Mon Desir Road, left onto Dehli Road and onto Gowers Well Road; and</li> <li>(d) Oropouche from Fyzabad, shall proceed along the Fyzabad-Guapo Road turning left onto the Siparia Old Road, right onto St. John Trace, left onto Ralph Narine Trace proceeding toward Oropouche Main Road and right at Ralph Narine Trace Junction.</li> </ul>
	<ul> <li>(2) Vehicular traffic proceeding to Siparia from—</li> <li>(a) Fyzabad, shall proceed in an easterly direction, onto Uriah Butler Avenue continuing onto the Fyzabad-Guapo Road; and</li> <li>(b) Forest Reserve, shall proceed in an easterly direction, onto Uriah Butler Avenue and then enter Evrehad Guapa Road</li> </ul>
	Uriah Butler Avenue and then onto Fyzabad-Guapo Road. (3) Notwithstanding subclause (2), between the hours of 2.00 p.m. and 10.00 p.m., vehicles proceeding to Siparia via Fyzabad shall proceed along Delhi Road onto Gowers Well Road, onto Fyzabad-Guapo Road and then onto Uriah Butler Avenue or the Oilfield Road through Sudama Village and Spring Trace.
Emergency routes	<ul> <li>6. Emergency routes are as follows:</li> <li>(a) vehicles proceeding to San Fernando via Fyzabad shall proceed along Delhi Road, onto Lutchman Drive, onto Sewlal Trace via Fyzabad Main Road, Pepper Village; and</li> <li>(b) vehicles proceeding to Siparia via Fyzabad shall proceed</li> </ul>

(b) vehicles proceeding to Siparia via Fyzabad shall proceed along Delhi Road, onto John Jules Trace, onto Gowers Well Road, turning right onto Guapo Road then turn left onto Sanderson Avenue (Butler Avenue) or proceed along Guapo Road and turn left onto Road No. 34 and proceed to Siparia Road. 7. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in  $_{of vehicles}^{impounding}$  contravention of this Order may be removed by the police and  $_{unlawfully}^{of vehicles}$  impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
