MADE BY THE MINISTER UNDER SECTION 65 OF THE MOTOR VEHICLES AND ROAD TRAFFIC ACT

THE TRAFFIC CONTROL (ARIMA) ORDER, 2010

1. This Order may be cited as the Traffic Control (Arima) Order, $_{\rm Citation}$ 2010.

2. Parking is prohibited on—

(a) the eastern side of Queen Street; and

(b) the northern side of Green Street.

3. Motorists shall proceed in—

- (a) a southerly direction along St. Joseph Street, between Church Street and Broadway;
- (b) a northerly direction along St. Joseph Street, between Hollis Avenue and Broadway;
- (c) a northerly direction along Woodford Street, between Hollis Avenue and Church Street;
- (d) a southerly direction along Queen Street, between Church Street and Hollis Avenue;
- (e) a westerly direction along Rose Street, between Woodford Street and King Street;
- (f) an easterly direction along Green Street, between King Street and Cocorite Street;
- (g) an easterly direction along Sorzano Street, between King Street and Prince Street;
- (h) a westerly direction along Sanchez Street, between Prince Street and King Street;
- (*i*) an easterly direction along Church Street, between King Street and Prince Street;
- (j) a southerly direction along Moreno Street, between Guanapo Road and Columbus Street;
- (k) a northerly direction along Thanno Lane, between Columbus Street and Guanapo Road;
- (*l*) a westerly direction along Broadway, between Guanapo Road and Queen Street; and
- (*m*) a southerly direction along Prince Street, between Sorzano Street and Broadway.

Two-way traffic	4. Motorists shall proceed in both directions along Industry Street.
No entry to maxi-taxis	5. Maxi-taxis shall not proceed in—
	(a) an easterly direction on Hollis Avenue, from St. Joseph Street;
	(b) a westerly direction on Lopez Street;
	(c) an easterly direction on Green Street, between King Street and St. Joseph Street; and
	(d) an easterly direction on Sorzano Street, between King Street and St. Joseph Street.
Stopping prohibited	6. Motorists are prohibited from stopping on—
	(a) John Shaw Avenue, one hundred metres west of Queen Mary Avenue; and
	(b) Queen Mary Avenue, between John Shaw Avenue and Railway Street.
Offence and penalty	7. A person who contravenes any of the provisions of this Order is liable on summary conviction to a fine of three thousand dollars or to imprisonment for three months.
Removal and impounding of vehicles unlawfully	8. Without prejudice to any other liability incurred by the commission of a summary offence, vehicles found parked in contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with section $108(1)(h)$ of the

contravention of this Order, may be removed by the Police and impounded and dealt with in accordance with section 108(1)(b) of the Motor Vehicles and Road Traffic Act.
