Made by the Commissioner of Police under Section 68(1) of the Motor Vehicles and Road Traffic Act

# THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (INTERFAITH SERVICE AND WREATH LAYING CEREMONY) ORDER, 2010

1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Interfaith Service and Wreath Laying Ceremony) Order, 2010.

2. This Order has effect between the hours of 6.00 a.m. and <sub>Duration</sub> 2.00 p.m. on Tuesday 27th July, 2010.

3. Drivers approaching the Red House for the Interfaith Service Vehicular and Wreath Laying Ceremony shall do so by way of St. Vincent Street, <sup>traffic routes</sup> Knox Street, Frederick Street, Hart Street and Abercromby Street.

4. (1) Subject to subclause (2), vehicular traffic is prohibited on the Vehicular following roads between the hours of 8.00 a.m and 2.00 p.m.:

(a) Abercromby Street, between Queen Street and Duke Street;

- (b) Knox Street;
- (c) Hart Street;
- (d) St. Vincent Street, between Duke Street and Queen Street;
- (e) Pembroke Street, between Duke Street and Knox Street; and
- (f) Sackville Street, between Edward Street and St. Vincent Street.
- (2) Vehicular traffic is permitted for—
- (a) the vehicles of—
  - (i) the President of the Senate;

### Traffic Restriction (Temporary Provisions) (Interfaith Service and Wreath Laying Ceremony) Order, 2010

- (ii) the Speaker of the House; and
- (iii) Ministers of Government; and
- (b) vehicles bearing green, blue, brown and red windscreen labels.

Parking 5. Subject to clause 6, parking is prohibited on the following roads between the hours of 6.00 a.m. and 6.00 p.m.:

- (a) Chancery Lane;
- (b) Sackville Street, between Richmond Street and St. Vincent Street;
- (c) Hart Street;
- (d) Abercromby Street, between Queen Street and Keate Street;
- (e) Keate Street, between Charlotte Street and Frederick Street;
- (f) Frederick Street, between Keate Street and Hart Street;
- (g) Gordon Street, between Chancery Lane and Abercromby Street;
- (h) Knox Street, between St. Vincent Street and Frederick Street;
- (i) St. Vincent Street, between Duke Street and Queen Street;
- (j) Pembroke Street, between Knox Street and Duke Street; and
- (k) Edward Street, between Queen Street and Duke Street.

Parking 6. (1) The following persons whose vehicles bear a brown windscreen label, may park their vehicles on the eastern side of Pembroke Street, between Duke Street and Knox Street:

- (a) Members of the Diplomatic Corps;
- (b) Heads of religious denominations; and
- (c) Judges of the Supreme Court.

(2) The following persons whose vehicles bear a red windscreen label may park their vehicles on the southern side of Knox Street, between Abercromby Street and Frederick Street:

- (a) the President of the Senate;
- (b) the Speaker of the House; and
- (c) Ministers of Government.

(3) A Member of Parliament, other than a Minister of Government for whom parking is reserved under subclause (2)(c), and whose vehicle bears a blue windscreen label may park his vehicle on—

- (a) St. Vincent Street, between Hart Street and Queen Street; and
- (b) Abercromby Street, between Hart Street and Queen Street.

(4) A driver of a vehicle bearing a green windscreen label and who is a guest attending the Interfaith Service and Wreath Laying Ceremony may park his vehicle on Hart Street, between Frederick Street and Abercromby Street.

(5) A driver of a vehicle of the Trinidad and Tobago Regiment may park that vehicle on Edward Street, between Queen Street and Sackville Street.

(6) A driver of a vehicle of the Justice On Time attached to the Port-of-Spain Magistrates' Court may park that vehicle on the eastern side of St. Vincent Street, between Duke Street and Knox Street.

7. Taxi drivers who normally ply—

Taxi stands

- (a) the St. Ann's route from the taxi stand on Hart Street, shall operate from the southern side of Queen Street, between Frederick Street and Abercromby Street; and
- (b) the St. James route from the taxi stand on Hart Street, shall operate from the western side of Henry Street, between Prince Street and Duke Street.

8. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in <sup>impounding</sup> contravention of this Order may be removed by the police and <sup>of vehicles</sup> unlawfully impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
