Made by the Commissioner of Police under section 68(1) of the Motor Vehicles and Road Traffic Act

THE TRAFFIC RESTRICTION (TEMPORARY PROVISIONS) (HOSEIN) ORDER, 2010

- 1. This Order may be cited as the Traffic Restriction (Temporary Citation Provisions) (Hosein) Order, 2010.
 - 2. This Order has effect from—

Duration

- (a) 10.00 p.m. on Tuesday 14th December, 2010 to 4.00 a.m. on Wednesday 15th December, 2010;
- (b) 10.00 p.m. on Wednesday 15th December, 2010 to 4.00 a.m. on Thursday 16th December, 2010;
- (c) 10.00 p.m. on Thursday 16th December, 2010 to 4.00 a.m. on Friday 17th December, 2010; and
- (d) 10.00 a.m. to 7.00 p.m. on Friday 17th December, 2010.
- 3. Vehicular traffic is prohibited on Western Main Road, between Vehicular Long Circular Road and George Cabral Street.

 traffic prohibited
- 4. (1) Vehicular traffic proceeding west along Tragarete Road shall Traffic routes turn south onto Damian Street and then onto Mucurapo Road.
- (2) Vehicular traffic proceeding east along Western Main Road shall turn north onto George Cabral Street, east onto Kathleen Street onto Delhi Street and then onto Barbados Road.
 - 5. (1) Parking is prohibited on—

Parking

- (a) Nepaul Street, between Western Main Road and prohibited Hyderabad Street;
- (b) Clarence Street, between Western Main Road and Anderson Street;
- (c) Dengue Street, between Western Main Road and Anderson Street;
- (d) Ethel Street, between Western Main Road and Finland Street;
- (e) Lazarrie Street, between Western Main Road and Carlton Avenue;

- (f) Romeo Street, between Western Main Road and Carlton Avenue;
- (g) Mathura Street, between Western Main Road and Carlton Avenue;
- (h) Long Circular Road, between Western Main Road and Barbados Road;
- (i) Bengal Street, between Western Main Road and Delhi Street;
- (j) Agra Street, between Western Main Road and Delhi Street;
- (k) Madras Street, between Western Main Road and Delhi Street;
- (l) Calcutta Street, between Western Main Road and Delhi Street;
- (m) Bombay Street, between Western Main Road and Church Street;
- (n) Mooneram Street, between Western Main Road and Church Street;
- (o) Brunton Road, between Western Main Road and Church Street;
- (p) Bournes Road, between Western Main Road and Church Street;
- (q) Jerry Street, between Western Main Road and Church Street; and
- (r) Salazar Street, between Western Main Road and Church Street.
- (2) On Friday 17th December, 2010, parking is prohibited on—
 - (a) Vidale Street, between Western Main Road and Anderson Street;
 - (b) Nizam Street, between Hyderabad Street and Western Main Road;
 - (c) George Cabral Street, between Kathleen Street and Western Main Road;
 - (d) Cawnpore Street, between Hyderabad Street and Western Main Road;
 - (e) Kathleen Street; and
 - (f) Delhi Street.

6. Without prejudice to any other liability incurred by the Removal and commission of a summary offence, vehicles found parked in impounding contravention of this Order may be removed by the Police and of vehicles impounded and dealt with in accordance with section 108(1)(b) of the parked Motor Vehicles and Road Traffic Act.
