CONDITIONS OF SALE:

- (1) All lots will be sold on an “as is” “where is” basis.
- (2) Notwithstanding, any law to the contrary, a person who purchases cargo at this Auction, shall be entitled to take delivery upon payment of:
 - (a) The purchase price payable to the Port Authority.
 - (b) Customs Duty equivalent to thirty (30%) per cent of the sale price shall be payable to the Customs & Excise Division Customs House.
 - (c) Any taxes or duties chargeable under any law other than duty imposed under the Customs Act calculated by reference to the purchase price.
- (3) Payment must be made to the Port Authority on the fall of the hammer either by cash or certified cheque. Debit/Credit cards will be accepted.
- (4) Persons failing to comply with condition (3) above will be debarred from further participating in the Auction Sales held by the Port Authority.
- (5) All auctioned cargoes must be removed from the Authority's Compound by the respective buyer/s within seven (7) working days subsequent to the Auction Sale, failing which store rent will be calculated, in accordance with the Port Authority's Tariff.
- (6) Items sold, but not claimed and removed by the respective buyers as per (5) above, shall be resubmitted for sale by the Authority at the next Auction Sale.
