APPOINTMENT OF A CUSTOMS AREA AND TRANSIT SHED

(*Customs Act, Chap. 78:01*)

IN EXERCISE of the powers conferred upon the Comptroller of Customs and Excise under the provisions of the Customs Act, Chap. 78:01, I, Fitzroy A. John, Comptroller of Customs and Excise, acting under the provisions of section 263(2) of the said Act, do hereby appoint the place specified in the Schedule hereto to be a Customs Area and Transit Shed for the storage, pending entry for home consumption or export of general goods, as shall be deposited by or in the Transit Shed of Messrs. Servisair Trinidad and Tobago Limited situated at Golden Grove Road, South Terminal Building, Piarco International Airport, Piarco, as indicated and described in Schedules I and II hereunto.

SCHEDULE I—CUSTOMS AREA

An area comprising a total area of 7,000 square metres and situated East of the South Terminal Building, Piarco International Airport, Piarco. The land is owned by Airports Authority of Trinidad and Tobago and leased to Servisair Trinidad and Tobago Limited. The said area is bounded on the east by Amerijet Limited and J.S.L. Speed Pak, on the west by the South Terminal Building, on the north by the Terminal Apron and the south by Golden Grove Road. The area is enclosed with chain link and razor wire fencing except for the south western entrance.

SCHEDULE II—TRANSIT SHED

The building is situated in the Customs Area described in Schedule I above. The said building measures 79.25 metres east to west and 30.48 metres north to south comprising a total of 2415.54 square metres. A two storey mezzanine floor is situated on the western side with the first floor consisting of an office for Customs and the upper floor having offices for Servisair Limited.

The building is constructed of concrete floor and walls while the roof is made up of steel beams and galvanized sheets. The entire premises is properly secured with Twenty-Four (24) hour security personnel and Closed Circuit Television.
