## PRIVATE BILL—AN ACT FOR THE INCORPORATION OF THE NATIONAL RAMLEELA COUNCIL OF TRINIDAD AND TOBAGO AND FOR MATTERS INCIDENTAL THERETO

PUBLIC NOTICE is hereby given in accordance with Standing Order No. 83(3)(b)(i) of the House of Representatives that it is intended to introduce in the House of Representatives the above-mentioned Bill.

2. Notice of the intended introduction of the Bill is being given in the *Trinidad and Tobago Gazette* and copies of the Bill may be purchased from the Government Printer.

3. The object of the Bill, among other things, is to incorporate the National Ramleela Council of Trinidad and Tobago of 72, St. John Trace, Avocat, in order to enable it to hold property and to otherwise carry out its aims and objectives.

Any person wishing to be heard in opposition to the Bill must lodge with the Clerk of the House a petition showing the nature of his objections to the Bill and stating whether his objections extend to the whole or some part of the preamble or to the clauses of the Bill and praying that he may be heard by himself or his counsel against the Bill.
